Explanatory Notes on Completion of Advance Return and Declaration of Election Donations

3. 根據《選舉（舞弊及非法行爲）條例》（第 554 章），“選舉捐贈” (election donation) 就某項選舉的一名候選人而言，指以下任何捐贈—

 - (b) any goods given to or in respect of the candidate for the purpose of promoting the election of the candidate or of prejudicing the election of another candidate or other candidates, and includes any goods given incidental to the provision of voluntary service;
 - (c) any service provided to or in respect of the candidate for the purpose of promoting the election of the candidate or of prejudicing the election of another candidate or other candidates, but does not include voluntary service.
