## 填寫委任選舉代理人通知書說明

### Notes on Completion of Notice of Appointment of Election Agent

1. 除非候選人以指明表格明文另作示明，有關代理人須當作是為在預定日期進行投票之補選而委任。  
The agent is to be regarded as being appointed for the by-election the poll at which is to be conducted on the scheduled date unless the candidate expressly indicates otherwise in the specified form.
2. 每一位候選人只可委任一名選舉代理人。凡年滿 18 歲的香港身分證持有人便可被委任為選舉代理人。然而，候選人應確保並無委任任何選舉主任、助理選舉主任，或任何已受總選舉事務主任委任協助進行投票或點票的人士（通常為政府公職人員）為其選舉代理人。  
A candidate may appoint one election agent only. Any person who is a holder of a Hong Kong Identity Card and has attained the age of 18 years may be appointed as an election agent. However, a candidate should ensure that he does not appoint as his election agent any Returning Officer, Assistant Returning Officer, or any person (usually a Government officer) already appointed by the Chief Electoral Officer to assist at the poll or at the count.
3. 填妥的委任通知指明表格，可由專人送遞或以郵遞或圖文傳真方式送交有關的選舉主任。委任通知書送交選舉主任後，該項委任方正式生效。  
The duly completed specified form of notice may be delivered by hand, sent by post or by facsimile transmission to the relevant Returning Officer. The appointment will not be effective until the notice is received by the Returning Officer.
4. 除了少數例外的事項外（請參閱表格第一部分第 2 段），獲正式委任的選舉代理人有權於選舉期內處理一切原本可由作出委任的候選人親自處理的必要事務，亦可於候選人缺席的任何時候，代表候選人採取任何與競選有關的行動。這些由選舉代理人採取的行動，效力與候選人親自採取的行動無異。選舉代理人可另獲候選人授權招致選舉開支。  
With a few exceptions (please make reference to paragraph 2 of Part I of the form), a duly appointed election agent has authority to do all things necessary at an election which can be done by the appointing candidate himself. He may also at any time in the absence of the candidate take any steps on behalf of the candidate in connection with the election. Any such acts carried out by the election agent are as effective as if they had been done by the candidate himself. An election agent can be authorized separately by the candidate to incur election expenses.
5. 本通知書第一部分應由候選人填寫（包括有關選舉代理人的姓名及住址）及簽署。第二部分應由選舉代理人填寫及簽署。填寫及簽署第一部分及第二部分時，均須有一位見證人在場。見證人可以是任何年滿 18 歲並持有身分證明文件的人士。見證人應填寫及簽署本通知書第三部分。根據《區議會條例》（第 547 章）第 2 條，“身分證明文件”（identity document）指—  
Part I of the notice should be completed (with name and residential address of the election agent given) and signed by the candidate. Part II should be completed and signed by the election agent. Both parts must be completed and signed in the presence of a witness who can be any person aged 18 years or over and in possession of an identity document. The witness is required to complete and sign Part III of the notice. According to section 2 of the District Councils Ordinance (Cap. 547), “identity document” (身分證明文件) means –
  - (a) 根據《人事登記條例》（第 177 章）向某人發出的身分證；或  
an identity card issued to a person under the Registration of Persons Ordinance (Cap. 177); or
  - (b) 在根據該條例訂立並正有效的規例下向某人發出，並證明該人獲豁免而無須根據該條例登記的文件；或  
a document issued to a person under regulations in force under that Ordinance certifying that the person is exempt from being required to register under that Ordinance; or
  - (c) 向某人發出的獲選舉登記主任接受為該人的身分證明的任何其他文件。  
any other document issued to a person that is acceptable to the Electoral Registration Officer as proof of the person’s identity.
6. 選舉主任會向有關選區的所有其他候選人送交載有選舉代理人詳情的通知。他亦會將該通知展示於辦事處外的顯眼地方。  
The Returning Officer will send to all other candidates for the constituency concerned a notice of particulars of election agents. He will also display such a notice in a prominent place outside his office.

7. 請注意下列有關在此通知書提供個人資料的說明－  
Please note the following with regard to the personal data supplied in connection with this notice –

(a) **資料用途**

就此通知書提供的個人及其他有關的資料，會供選舉事務處及選舉主任用於與選舉有關的用途。

**Purpose of Collection**

The personal data and other related information supplied in connection with this notice will be used by the Registration and Electoral Office and the Returning Officer for election-related purposes.

(b) **資料轉介**

此通知書內的資料可能會提供予其他獲授權的部門或機構，用於與選舉有關的用途。另外，選舉主任會根據《選舉管理委員會（選舉程序）（區議會）規例》（第 541 章，附屬法例 F）第 27 條向有關選區的其他候選人送交選舉代理人詳情（包括其姓名及住址）的通知，並在選舉主任辦事處外的顯眼地方，展示關於選舉代理人詳情的公告。

**Transfer of Information**

The information provided in this notice may be provided to other authorized departments/agencies for election-related purposes. Besides, the Returning Officer will, in accordance with section 27 of the Electoral Affairs Commission (Electoral Procedure) (District Councils) Regulation (Cap. 541 sub. leg. F), send to other candidates for the constituency concerned a notice containing the particulars of election agents (including their names and residential addresses) and display, in a prominent place outside that Officer's office, a notice of the particulars of the election agents.

(c) **索閱個人資料**

任何人有權根據《個人資料（私隱）條例》（第 486 章）的條文要求索閱及改正他所提供的個人資料。

**Access to Personal Data**

A person has the right to request access to and correction of the personal data he supplied in accordance with the provisions of the Personal Data (Privacy) Ordinance (Cap. 486).

(d) **查詢**
