填寫撤銷授權招致選舉開支通知書說明

Notes on Completion of Notice of Revocation of Authorization to Incur Election Expenses

1. 有關招致選舉開支的授權書除非在有關的選舉期間結束前被撤銷，否則該等授權書持續有效，直至有關的選舉期間結束為止。如要撤銷授權，作出該項授權的候選人須藉專人送遞或郵遞或圖文傳真方式，把撤銷授權招致選舉開支通知書送交有關的選舉主任或（如未委任選舉主任）總選舉事務主任。

An authorization to incur election expenses remains in force until the end of the relevant election period unless it is revoked earlier. If an authorization is to be revoked, the candidate who made the authorization must give a Notice of Revocation of Authorization to Incur Election Expenses to the relevant Returning Officer, or if the Returning Officer has not been appointed, to the Chief Electoral Officer by hand, by post or by facsimile transmission.

2. 撤銷授權招致選舉開支通知書只有在有關的選舉主任或（如未委任選舉主任）總選舉事務主任收到撤銷通知後方生效。

The revocation of authorization to incur election expenses will not be effective until the relevant notice is received by the relevant Returning Officer, or the Chief Electoral Officer if the Returning Officer has not been appointed.

3. 根據《區議會條例》（第 547 章）第 2 條，“身分證明文件”（identity document）指—
According to section 2 of the District Councils Ordinance (Cap. 547), “identity document” (身分證明文件) means –

- (a) 根據《人事登記條例》（第 177 章）向某人發出的身分證；或
an identity card issued to a person under the Registration of Persons Ordinance (Cap. 177); or
- (b) 在根據該條例訂立並正有效的規例下向某人發出，並證明該人獲豁免而無須根據該條例登記的文件；或
a document issued to a person under regulations in force under that Ordinance certifying that the person is exempt from being required to register under that Ordinance; or
- (c) 向某人發出的獲選舉登記主任接受為該人的身分證明的任何其他文件。
any other document issued to a person that is acceptable to the Electoral Registration Officer as proof of the person’s identity.

4. 候選人應將通知書的副本交予被撤銷授權的人士。
A copy of the notice should be sent to the person whose authorization has been revoked.

5. 請注意下列有關在此通知書內提供個人資料的說明—
Please note the following with regard to the personal data supplied in connection with this notice –

- (a) **資料用途**

Purpose of Collection

The personal data and other related information supplied in connection with this notice will be used by the Registration and Electoral Office and the Returning Officer for election-related purposes.

- (b) **資料轉介**
此通知書內的資料可能會提供予其他獲授權的部門或機構，用於與選舉有關的用途。

Transfer of Information

The information provided in this notice may be provided to other authorized departments/agencies for election-related purposes.

- (c) **索閱個人資料**
任何人有權根據《個人資料（私隱）條例》（第 486 章）的條文要求索閱及改正他所提供的個人資料。

Access to Personal Data

A person has the right to request access to and correction of the personal data he supplied in

accordance with the provisions of the Personal Data (Privacy) Ordinance (Cap. 486).

(d) **查詢**
