I, understand that if the content or type of the advertisement items has been revised through this corrective declaration as compared to that shown in the original declaration, the following would need to be deposited with the Returning Officer –

- (a) 每款經修訂的宣傳印刷品的兩份以原本顏色印製的文本，印有印刷商中文或英文姓名或名稱及地址、印刷日期，以及印刷數量；
two copies of each of the revised printed advertisements in original colours, bearing, in Chinese or English, the name and address of the printer together with the date of printing and the number of copies printed;
- (b) 錄有每款經修訂的選舉廣告的錄影帶／錄音帶或光碟或磁碟的兩份複製品；
two identical copies of any revised video/audio tapes or discs or diskettes containing election advertisements;
- (c) 以電子媒介傳送的經修訂的競選資料的兩份文本（如屬網站而其內容有所更改或更新，則提交任何經修訂網頁的兩份文本）；及
two copies of any revised electioneering message disseminated by electronic means (including two copies of any modified webpages if the contents of the website have been changed or updated); and
- (d) 如因實際情況不能或不便影印，該等經修訂的選舉廣告的彩色相片（明信片尺寸）一式兩張。
two identical postcard-sized colour photographs of each type of the revised election advertisements which cannot be practically or conveniently photocopied.

4. 本人亦明白所有修訂聲明必須最遲於投票日前一天（即 2010 年 9 月 4 日）正午十二時向選舉主任繳存。所提交的修訂聲明，以及第 1 段所指的選舉廣告聲明，會一同被作為依據，用以審查和核對候選人的「選舉開支及接受選舉捐贈之申報書及聲明書」（表格編號：REO/C/1/2010DC(By-E)(SF)），和用以拆除未經批准而展示或違規展示的選舉廣告。

I also understand that all corrective declarations must be deposited with the Returning Officer at the latest **by 12:00 noon on the day preceding the polling day (i.e. 4 September 2010)**. Any corrective declaration so deposited will be used together with the Declaration of Election Advertisements referred to in paragraph 1 above as the bases for examining and checking the “Return and Declaration of Election Expenses and Election Donations” (form no.: REO/C/1/2010DC(By-E)(SF)) of the candidate, and as the basis for removal of unauthorized or offending displays.

Notes on Completion of Corrective Declaration of Election Advertisements

1. 若候選人或其選舉代理人向選舉主任呈交的「選舉廣告聲明」（表格編號：REO/C/10/2010DC(By-E)(SF)）有任何錯誤，或所聲明擬展示的任何類型的選舉廣告的數量或展示地點等有所更改，候選人或其選舉代理人應向選舉主任作出修訂聲明，更正有關錯誤或將有關選舉廣告展示、分發或作其他用途的更改記錄在案。

If a “Declaration of Election Advertisements” (form no.: REO/C/10/2010DC(By-E)(SF)) deposited by the candidate or his election agent with the Returning Officer contains a mistake or if the candidate’s or his election agent’s declared intention as to the number of any type of election advertisements to be displayed or the location of display, etc. has been changed, the candidate or his election agent should make a corrective declaration to the Returning Officer to correct the mistake or record his changed intention as to the details of election advertisements displayed or distributed or otherwise used.

- (a) **資料用途**

就此修訂聲明提供的個人及其他有關的資料，會供選舉事務處及選舉主任用於與選舉有關的用途。

Purpose of Collection

The personal data and other related information supplied in connection with this corrective declaration will be used by the Registration and Electoral Office and the Returning Officer for election-related purposes.

- (b) **資料轉介**

選舉主任收到選舉廣告聲明、修訂聲明、批准書、授權書、同意書、牌照及選舉廣告樣本後，會將副本供公眾查閱。在展示前，文件內所列的身分證明文件號碼將會被遮蓋。有關的資料可能會提供予其他獲授權的部門或機構，用於與選舉有關的用途。

Transfer of Information

A copy of the declaration, corrective declaration, permission, authorization, consent, licence and sample of election advertisement received by the Returning Officer will be made available for public inspection. All identity document numbers as shown in the documents will be covered before display. The information concerned may be provided to other authorized departments/agencies for election-related purposes.

- (c) **索閱個人資料**

Access to Personal Data

A person has the right to request access to and correction of the personal data he supplied in accordance with the provisions of the Personal Data (Privacy) Ordinance (Cap. 486).
