Notes on Completion of Notice of Revocation of Appointment of Agent

- 1. 候選人可撤銷任何類別的代理人的委任。選舉代理人只可撤銷監察投票代理人或監察點票代理人的委任。 A candidate may revoke the appointment of any type of agent. An election agent may only revoke the appointment of a polling agent or a counting agent.
- 2. 選舉代理人委任的撤銷,只可在選舉主任收到撤銷通知書時方生效。

The revocation of the appointment of an election agent will not be effective until the relevant notice of revocation is received by the Returning Officer.
