Notes Under section 104A of the Public Health and Municipal Services Ordinance (Cap. 132), a person is prohibited from displaying or affixing a bill or poster on any private land or Government land unless a written permission is obtained from the owner or occupier thereof or the Authority.

To ensure the smooth conduct of electioneering activities in public or private places, it is always desirable for candidates to consult the relevant authorities or management in advance and to obtain permission from them for the conduct of electioneering activities in the places within their jurisdiction, if required.

- (3) 除此批准書內所列的選舉廣告及／或競選活動外，候選人不可在大廈內的其他地方展示／分發選舉廣告或進行其他競選活動。
No election advertisements and/or electioneering activities of the candidate are allowed in the building other than those detailed in this permission.

Notes

- (1) 根據《區議會選舉活動指引》第七章，候選人須在展示／分發選舉廣告前，預先向選舉主任繳存展示／分發選舉廣告的批准書。
In accordance with Chapter 7 of the Guidelines on Election-related Activities in respect of the District Council Election, the candidate should deposit a copy of the permission for display/distribution of election advertisement with the Returning Officer prior to their display/distribution.
- (2) 此批准書應一式三份填寫，其中一份應呈交予有關的選舉主任存案，候選人及業主／佔用人／大廈管理組織亦應各自保存一份。
This permission should be completed in triplicate. One copy of the permission should be deposited with the relevant Returning Officer. The candidate and the owners/occupiers/building management should each retain a copy.
- (3) 在不違反平等對待的原則下，業主／佔用人／大廈管理組織有權對此批准書內各項目、規定及條文作出修改、增加或刪減。
The owners/occupiers/building management is at full liberty to amend, add or delete any items, terms and conditions in this permission, provided that they do not breach the fair and equal treatment principle.

Purpose of Collection

(b) **資料轉介**

Transfer of Information

The information provided in this permission will be made available for public inspection. All identity document numbers in the permission will be covered before display. The information concerned may be provided to other authorized departments or agencies for election-related purposes.
