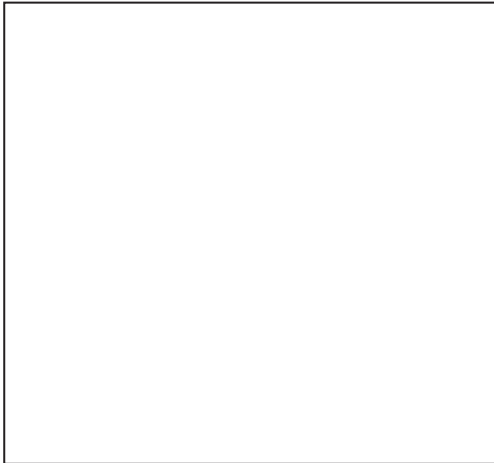

- (c) 向某人發出的獲選舉登記主任接受為該人的身分證明的任何其他文件。
