填寫候選人退選通知書說明

Notes on Completion of Notice of Withdrawal of Candidature

- 獲提名而欲退出選舉的候選人，須填寫本通知書。通知書須由候選人於見證人在場下簽署。任何年滿 18 歲並持有身分證明文件的人士，均可擔任見證人。根據《區議會條例》（第 547 章）第 2 條，“身分證明文件”（identity document）指—
This notice should be used by a nominated candidate who wishes to withdraw his candidature. It should be signed by the candidate in the presence of a witness who can be any person aged 18 years or over and in possession of an identity document. According to section 2 of the District Councils Ordinance (Cap. 547), “identity document” (身分證明文件) means –
 - 根據《人事登記條例》（第 177 章）向某人發出的身分證；或
an identity card issued to a person under the Registration of Persons Ordinance (Cap. 177); or
 - 在根據該條例訂立並正有效的規例下向某人發出，並證明該人獲豁免而無須根據該條例登記的文件；或
a document issued to a person under regulations in force under that Ordinance certifying that the person is exempt from being required to register under that Ordinance; or
 - 向某人發出的獲選舉登記主任接受為該人的身分證明的任何其他文件。
any other document issued to a person that is acceptable to the Electoral Registration Officer as proof of the person’s identity.
