A claim may be withdrawn, before a payment of financial assistance is made or the claim is otherwise disposed of, by means of a notice of withdrawal presented to the Chief Electoral Officer. The notice of withdrawal must be in this specified form (REO/C/22/2011DC(By-E)(SF)).
