Explanatory Notes on Completion of Advance Return and Declaration

1. 在填寫此表格前，請細心閱讀《選舉（舞弊及非法行為）條例》（第 554 章）。

3. 根據《選舉（舞弊及非法行為）條例》（第 554 章），“選舉捐贈”(election donation)就某項選舉的一名候選人而言，指以下任何捐贈—
 - (a) 為償付或分擔償付該候選人的選舉開支，而給予該候選人或就該候選人而給予的任何金錢；

According to the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554), “election donation”(選舉捐贈), in relation to a candidate at an election, means any of the following donations –

 - (a) any money given to or in respect of the candidate for the purpose of meeting, or contributing towards meeting, the election expenses of the candidate;
 - (b) any goods given to or in respect of the candidate for the purpose of promoting the election of the candidate or of prejudicing the election of another candidate or other candidates, and includes any goods given incidental to the provision of voluntary service;
 - (c) any service provided to or in respect of the candidate for the purpose of promoting the election of the candidate or of prejudicing the election of another candidate or other candidates, but does not include voluntary service.
