# 填寫候選人退選通知書說明

## Notes on Completion of Notice of Withdrawal of Candidature

1. 獲提名而欲退出選舉的候選人，須填寫本通知書。通知書須由候選人於見證人在場下簽署。任何年滿 18 歲並持有香港身份證的人士，均可擔任見證人。

This notice should be used by a nominated candidate who wishes to withdraw his candidature. It should be signed by the candidate in the presence of a witness who can be any person aged 18 years or over and in possession of a Hong Kong Identity Card.

2. 本通知書第二部分須由見證人填寫及簽署。

The witness is required to complete and sign Part II of this notice.

3. 本通知書填妥及簽署後，應於提名期結束前（即 2007 年 10 月 15 日或之前）由候選人或候選人的選舉代理人親自送交有關的選舉主任。在該日期後，將不接受退選。選舉主任的地址已刊登在憲報內。

This notice, when completed and signed, should be delivered to the relevant Returning Officer by the candidate or the candidate's election agent in person **before the close of nominations (i.e. by 15 October 2007)**. Withdrawal will not be accepted after that date. The address of the Returning Officer has been specified in the Gazette.

Please note the following with regard to the personal data supplied in connection with this notice-

(a) **資料用途**

就此通知書提供的個人及其他有關的資料，會供選舉事務處及選舉主任用於與選舉有關的用途。

**Purpose of Collection**

The personal data and other related information supplied in connection with this notice will be used by the Registration and Electoral Office and the Returning Officer for election-related purposes.

(b) **資料轉介**

此通知書內的資料可能會提供予其他獲授權的部門或機構，用於與選舉有關的用途。

**Transfer of Information**

The information provided in this notice may be provided to other authorized departments/agencies for election-related purposes.

(c) **索閱個人資料**

任何人有權根據《個人資料（私隱）條例》（第 486 章）的條文要求索閱及改正他所提供的個人資料。

**Access to Personal Data**

A person has the right to request access to and correction of the personal data he supplied in accordance with the provisions of the Personal Data (Privacy) Ordinance (Cap. 486).

(d) **查詢**
