## 填寫撤銷委任代理人通知書說明

### Notes on Completion of Notice of Revocation of Appointment of Agent

1. 候選人可隨時撤銷任何類別的代理人的委任。選舉代理人只可撤銷監察投票代理人或監察點票代理人的委任。  
A candidate may revoke the appointment of any type of agent at any time. An election agent may only revoke the appointment of a polling agent or a counting agent.
2. 選舉代理人委任的撤銷，只可在有關的選舉主任收到撤銷通知書時方生效。  
The revocation of the appointment of an election agent will not be effective until the relevant notice of revocation is received by the relevant Returning Officer.
3. 監察投票代理人委任的撤銷，只可在下列情況下方生效 –  
The revocation of the appointment of polling agent(s) will not be effective until the relevant notice of revocation is received by –
  - (a) 有關的選舉主任於投票日之前收到撤銷委任通知書；或  
the relevant Returning Officer before polling day; or
  - (b) 有關的投票站主任於投票日收到由候選人或其選舉代理人親自遞交的撤銷委任通知書。  
the relevant Presiding Officer from the candidate or his election agent personally on polling day.
4. 監察點票代理人委任的撤銷，只可在下列情況下方生效 –  
The revocation of the appointment of counting agent(s) will not be effective until the relevant notice of revocation is received by –
  - (a) 有關的選舉主任於投票日之前收到撤銷委任通知書；或  
the relevant Returning Officer before polling day; or
  - (b) 有關的投票站主任於投票日收到由候選人或其選舉代理人親自遞交的撤銷委任通知書。  
the relevant Presiding Officer from the candidate or his election agent personally on polling day.
5. 除上述第 3(b)及 4(b)項另有規定外，各類代理人的撤銷委任通知書均可由專人送遞或以郵遞或圖文傳真方式發送。  
Subject to Notes 3(b) and 4(b) above, the notice of revocation of appointment for various types of agents may be delivered by hand, sent by post or by facsimile transmission.
6. 候選人或其選舉代理人應將撤銷委任通知書的副本交予被撤銷委任的人。  
A copy of the notice of revocation of appointment should be sent to the person whose appointment as agent has been revoked.

  - (a) **資料用途**

**Purpose of Collection**  
The personal data and other related information supplied in connection with this notice will be used by the Registration and Electoral Office, the Returning Officer and the Presiding Officers for election-related purposes.
  - (b) **資料轉介**  
此通知書內的資料可能會提供予其他獲授權的部門或機構，用於與選舉有關的用途。  
**Transfer of Information**  
The information provided in this form may be provided to other authorized departments/agencies for election-related purposes.
  - (c) **索閱個人資料**  
任何人有權根據《個人資料（私隱）條例》（第486章）的條文要求索閱及改正他所提供的個人資料。  
**Access to Personal Data**  
A person has the right to request access to and correction of the personal data he supplied in accordance with the provisions of the Personal Data (Privacy) Ordinance (Cap. 486).
  - (d) **查詢**
