I also understand that these appointments of counting agent(s) may be revoked by me before the polling day by delivering by hand, by post, by electronic mail or by facsimile transmission to the relevant Returning Officer, or on the polling day by delivering in person to the relevant Returning Officer a notice in writing and signed by me to that effect.

*I/Each of us, whose particulars are shown in paragraph 1 above, hereby accept(s) the appointment as stated in Part I of this notice.

6. *我／我們每人均明白，*我／我們須事先作出保密聲明，並於投票當日到達點票站後，向有關的選舉主任報到時出示該保密聲明及*我／我們之香港身分證。

*I/Each of us understand(s) that *I/we must make a Declaration of Secrecy in advance and produce such Declaration of Secrecy and *my/our Hong Kong Identity Card(s) when reporting to the relevant Returning Officer on attending the counting station on the polling day.

7. *我／我們每人亦明白，*我／我們不得—

*I/Each of us further understand(s) that *I/we must not—

- (a) 向他人傳達在點票時取得的資料，包括任何一張選票所選之候選人；
communicate to any person any information obtained at the counting of the votes including the candidate for whom a vote has been given on any particular ballot paper;
- (b) 觸摸、處理、分開或排列選票；
touch, handle, separate or arrange ballot papers;
- (c) 干擾或企圖干擾任何投票箱、選票結算表、選票結算核實書或覆核書、或其他有關的選舉物料；或
interfere with or attempt to interfere with any ballot boxes, ballot paper accounts, verifications or re-verifications of such accounts or other relevant election materials; or
- (d) 在點票過程拍影片、拍照、錄音或錄影。
film, take photograph or make any audio or video recording during the counting process.

8. *我／我們每人均明白，倘若*我／我們在點票站內或其鄰近範圍內行為不檢，或沒有遵從總選舉主任或有關選舉主任作出的任何合法命令，即屬違法，可被判罰款 5,000 元及監禁 3 個月，並可能會被總選舉主任或有關選舉主任命令立即離開該地方。倘若*我／我們沒有離開，可能會被警務人員或獲總選舉主任或有關選舉主任（視何者適用而定）以書面授權的人員逐離該地方。*我／我們被逐離後，除非獲得總選舉主任或有關選舉主任的許可，否則不得在同日再次進入點票站。

*I/Each of us also understand(s) that if *I/we at or in the vicinity of the counting station, behave in a disorderly manner or fail to comply with any lawful order given by the Chief Returning Officer or the relevant Returning Officer, *I/we shall commit an offence punishable with a fine of \$5,000 and imprisonment for 3 months and may be ordered by the Chief Returning Officer or the relevant Returning Officer to leave the area immediately. *My/Our failure to leave the area may result in *my/our being removed by a police officer or a person authorised in writing by the Chief Returning Officer or the relevant Returning Officer, as may be appropriate. If *I am/we are so removed, *I/we may not re-enter the counting station on that day except with the permission of the Chief Returning Officer or the relevant Returning Officer.

Notes on Completion of Notice of Appointment of Counting Agents

1. 除非候選人以指明表格明文另作示明，有關代理人須當作是為在預定日期進行的投票中和（如適用的話）於遭押後的該次投票中所投的票的點算而委任。

The agent is to be regarded as being appointed for the counting of the votes cast in the poll to be conducted on the scheduled date and (where applicable) the postponed or adjourned poll, unless the candidate expressly indicates otherwise in the specified form.

2. 選舉委員會界別分組選舉的點票工作會於中央點票站進行。每名候選人或其選舉代理人可就在該候選人獲提名的界別分組／小組委任不超過 2 名監察點票代理人。凡年滿 18 歲的香港身分證持有人均可被委任為監察點票代理人。候選人或其選舉代理人不應委任任何總選舉主任、選舉主任、助理選舉主任、或任何已受總選舉事務主任委任協助進行投票或點票的人士（通常為政府公職人員）為其監察點票代理人。

The counting of votes for the Election Committee Subsector Elections will be conducted in the central counting station. Each candidate or his/her election agent may appoint not more than 2 counting agents in respect of the subsector/sub-subsector for which the candidate is nominated. Any person who is a holder of a Hong Kong Identity Card and has attained the age of 18 years may be appointed as a counting agent. However, a candidate or his/her election agent should not appoint any Chief Returning Officer, Returning Officer, Assistant Returning Officer, or any person (usually a government officer) already appointed by the Chief Electoral Officer to assist at the poll or at the count as his/her counting agent.

3. 此通知書的第一部分應由候選人或其選舉代理人填寫及簽署。第二部分應由各個監察點票代理人填寫及簽署。

Part I of this notice should be completed and signed by the candidate or his/her election agent. Part II should be completed and signed by each of the counting agents.

4. 委任監察點票代理人的委任通知書，須於投票日前的第 7 天或之前（即 2016 年 12 月 4 日或之前）藉專人送遞、郵遞、電子郵件或圖文傳真方式送交有關的選舉主任，或於投票日由候選人或選舉代理人親自向有關的選舉主任遞交。逾期遞交的通知將不予接納。監察點票代理人的委任，在選舉主任接獲委任通知書後始生效。

Notice of appointment of counting agents must be delivered to the relevant Returning Officer by hand, by post, by electronic mail or by facsimile transmission at least 7 days before the polling day (i.e. on or before 4 December 2016), or be given by the candidate or the election agent in person to the relevant Returning Officer on the polling day. Late submissions will not be accepted. The appointment of counting agents will not be effective until the notice of appointment is received by the Returning Officer.

The personal data and other related information supplied in connection with this notice will be used by the Electoral Affairs Commission, the Registration and Electoral Office, the Chief Returning Officer, the relevant Returning Officer and other related government departments for election-related purposes.

(b) **資料轉介**

Transfer of Information

The personal data and other related information supplied in connection with this notice may be provided to other authorised departments or persons including but not limited to the law courts for election-related purposes.

(c) **索閱個人資料**

任何人有權根據《個人資料（私隱）條例》（第 486 章）的條文要求索閱及改正他／她所提供的個人資料。

Access to Personal Data

A person has the right to request access to and correction of the personal data he/she supplied in accordance with the provisions of the Personal Data (Privacy) Ordinance (Cap 486).

(d) **個人資料保障原則**

請注意，候選人／選舉代理人在收集第三者的個人資料以填寫此通知書時，須遵守《個人資料（私隱）條例》（第 486 章）附表 1 的保障資料原則，特別是第 4 原則，即採取所有切實可行的步驟，以確保資料受到保障而不受未獲准許的或意外的查閱和處理。

Personal Data Protection Principles

Please note that candidates/election agents must observe the Data Protection Principles in Schedule 1 to the Personal Data (Privacy) Ordinance (Cap 486) in collecting personal data of a third person in completing this notice, in particular Principle 4 concerning the requirement to take all practicable steps to ensure that personal data are protected against unauthorised or accidental access and processing.
