# Notes on Completion of Notification of Corrected Information in relation to Election Advertisements

- 1. 根據《選舉管理委員會(選舉程序)(區議會)規例》(第 541F 章)第 105(1)條, "發布"是指印刷、展示、展覽、分發、張貼、公布或以任何其他方式使公眾獲知,並包括繼續發布。
  - According to section 105(1) of the Electoral Affairs Commission (Electoral Procedure) (District Councils) Regulation (Cap. 541F), "publish" means print, display, exhibit, distribute, post up, publicly announce or make publicly known by any other means, and includes continue to publish.
- 2. "准許"是指私人土地的擁有人或佔用人或政府土地的主管當局根據《公眾衞生及市政條例》(第 132 章)第 104A(1)條,就候選人在該土地展示或張貼招貼或海報而給予的書面准許。
  - "Permission" means the written permission of the owner or the occupier of any private land or the authority of any government land given pursuant to section 104A(1) of the Public Health and Municipal Services Ordinance (Cap. 132) for a candidate to display or affix a bill or poster on such land.
- 3. "同意書"是指任何人或組織根據《選舉(舞弊及非法行為)條例》(第554章)第27條,就候選人發布或授權發布收納了該人或組織的姓名、名稱或標識或跟該人或組織有關聯的姓名、名稱或標識;或與該人或組織的姓名、名稱或標識或與跟該人或組織有關聯的姓名、名稱或標識甚為相似的姓名、名稱或標識;或該人的圖像的選舉廣告,而給予的書面同意。
  - "Consent" means the consent in writing given by any person or organisation pursuant to section 27 of the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554) for a candidate to publish or authorise the publication of an election advertisement that includes the name or logo of or associated with the person or organisation; or a name or logo that is substantially similar to the name or logo of or associated with the person or organisation; or a pictorial representation of the person.
- 4. 候選人必須確保遞交的選舉廣告詳情符合《選舉管理委員會(選舉程序)(區議會)規例》(第 541F章)第106條及《區議會選舉活動指引》第七章的規定及要求。候選人必須<u>藉專人送遞或郵遞</u> 向有關的選舉主任繳存此修正通知書。
  - The candidate must ensure that the election advertisement particulars submitted comply with the rules and requirements as set out in section 106 of the Electoral Affairs Commission (Electoral Procedure) (District Councils) Regulation (Cap. 541F), and Chapter 7 of the "Guidelines on Election-related Activities in respect of the District Council Election". The candidate must deposit this Notification of Correction with the relevant Returning Officer by hand or by post.
- 5. 候 選 人 只 可 用 此 修 正 通 知 書 修 正 先 前 所 遞 交 的 「 選 舉 廣 告 資 料 摘 要 」 ( 表 格 編 號 : REO/C/10/DC(SF)(2017)) 內的選舉廣告資料(例如選舉廣告的類別、製作/印刷/發布日期、製作/印刷/發布的文本數目、製作人/印刷人的姓名及地址等)。如候選人的選舉廣告內容曾作出修改,則應重新提交一份「選舉廣告資料摘要」(表格編號:REO/C/10/DC(SF)(2017))。
  - A candidate may only make use of this Notification of Correction to correct information related to election advertisements on the "Information Sheet in relation to Election Advertisements" (Form no.: REO/C/10/DC(SF)(2017)) submitted previously (e.g. type of election advertisement, date of production/printing/publication, number of copies produced/printed/published, name and address of the producer/printer etc.). If a candidate has amended the content of election advertisements, he/she should submit another "Information Sheet in relation to Election Advertisements" (Form no.: REO/C/10/DC(SF)(2017)).
- 6. 在此修正通知書中提及的選舉廣告,若候選人曾就其類別作出修正,他/她必須向有關的選舉主任繳存 下列資料-
  - A candidate must deposit with the relevant Returning Officer the following information in respect of any correction to the type of election advertisements mentioned in this Notification of Correction -
  - (a) 每個選舉廣告的印本形式文本 2 份(或就每個實際上不能或不便以同樣方式出示的選舉廣告,提 交一式兩份全彩色相片/打印本/影印本),以及提供與該選舉廣告有關的准許或同意書的印本 形式文本1份(如適用);或
    - two hard copies each of the election advertisements (or 2 identical full colour photographs/printouts/photocopies of each election advertisement which cannot be practically or conveniently produced in specie) and 1 hard copy each of the relevant permission or consent (if applicable); or

- (b) 兩份唯讀光碟(CD-ROM)或唯讀型數碼多功能光碟(DVD-ROM),每份載有相同的選舉廣告,以及提供與該選舉廣告有關的准許或同意書的印本形式文本 1 份(如適用)。 two copies of a CD-ROM or DVD-ROM each containing the identical election advertisements and 1 hard copy each of the relevant permission or consent (if applicable).
- 7. 所有修正通知書必須最遲於選舉日後 2 個工作天(即公眾假期及星期六以外的任何一天)內或在押後的 選舉日之後的 2 個工作天內(如適用)向選舉主任繳存。所提交的修正通知書,以及此修正通知書第 1 頁第 1 段所指的「選舉廣告資料摘要」,會一同被作為其中一個依據,用以審查和核對候選人的「選舉 開支及接受選舉捐贈之申報書及聲明書」。

All Notification of Correction must be deposited with the Returning Officer not later than 2 working days (i.e. any day other than a general holiday and Saturday) after the polling day or not later than 2 working days after the postponed or adjourned polling day, where applicable. Any Notification of Correction so deposited will be used together with the "Information Sheet in relation to Election Advertisements" mentioned at paragraph 1 of page 1 of this Notification of Correction as one of the bases for examining and checking the "Return and Declaration of Election Expenses and Election Donations" of the candidate.

- 8. 如尚未委任選舉主任,在此修正通知書中所提述選舉主任之處,均須解釋為提述總選舉事務主任。
  If the Returning Officer has not yet been appointed, the references in this Notification of Correction to a Returning Officer are to be construed as references to the Chief Electoral Officer.
- 9. 候選人在填寫此修正通知書時如有任何問題,請在辦公時間內致電選舉事務處的查詢熱線 2891 1001。 If the candidate has any questions in completing this Notification of Correction, please call the Enquiry Hotline of the Registration and Electoral Office at 2891 1001 during office hours.
- 10. 請注意下列有關在此修正通知書提供個人資料的說明-Please note the following with regard to the personal data supplied in connection with this Notification of Correction -

#### (a) <u>資料用途</u>

就此修正通知書提供的個人及其他有關的資料,會供選舉管理委員會、選舉事務處、有關的選舉 主任及其他有關的政府部門用於與選舉有關的用途。

#### **Purpose of Collection**

The personal data and other related information supplied in connection with this Notification of Correction will be used by the Electoral Affairs Commission, the Registration and Electoral Office, the relevant Returning Officer and other related government departments for election-related purposes.

#### (b) 資料轉介

選舉主任收到有關的資料摘要、此修正通知書、准許或授權書、同意書或選舉廣告樣本後,<u>會將</u> 副本供公眾查閱直至選舉申報書的文本根據《選舉(舞弊及非法行為)條例》(第 554 章) 第 41 條可供查閱的期間結束為止。在展示前,文件內所有身分證明文件號碼及電話號碼將會被遮蓋。就此修正通知書提供的個人及其他有關的資料亦可能會提供予其他獲授權的部門或人士,包括但不限於法院,用於與選舉有關的用途。

#### **Transfer of Information**

A copy of the relevant information sheet, this Notification of Correction, permission or authorisation, consent or election advertisement will be made available by the Returning Officer who has received them for public inspection until the end of the period for which copies of election returns are available for inspection pursuant to section 41 of the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554). All identity document numbers and telephone numbers in the documents will be covered before display. The personal data and other related information supplied in connection with this Notification of Correction may also be provided to other authorised departments or persons including but not limited to the law courts for election-related purposes.

#### (c) 索閱個人資料

任何人有權根據《個人資料(私隱)條例》(第 486 章)的條文要求索閱及改正他/她在此修正 通知書所提供的個人資料。

#### **Access to Personal Data**

A person has the right to request access to and correction of the personal data he/she supplied in this Notification of Correction in accordance with the provisions of the Personal Data (Privacy) Ordinance (Cap. 486).

#### (d) 個人資料保障原則

候選人及代理人在收集第三者的個人資料以填寫此修正通知書時,須遵守《個人資料(私隱)條例》(第 486 章)附表 1 的保障資料原則,特別是第 4 原則,即採取所有切實可行的步驟,以確保資料受到保障而不受未獲准許的或意外的查閱和處理。

#### **Personal Data Protection Principles**

Candidates and agents are reminded to observe the Data Protection Principles in Schedule 1 to the Personal Data (Privacy) Ordinance (Cap. 486) in collecting personal data of a third person in completing this Notification of Correction, in particular Principle 4 concerning the requirement to take all practicable steps to ensure that the personal data are protected against unauthorised or accidental access and processing.
