Procedural Guide on Submission of Election Advertisements onto the Central Platform

本程序指引是根據「立法會選舉活動指引」第八章及附錄五有關呈交選舉廣告及有關資料擬定。 This procedural guide is provided for the submission of election advertisements ("EAs") and relevant information in accordance with Chapter 8 and Appendix E of the "Guidelines on Election-related Activities in respect of the Legislative Council Election".

(I) <u>申請用戶</u> Application for an Account

(1) 候選人在使用中央平台呈交選舉廣告前,請將已填妥的表格「中央平台 戶口申請表及有關候選人使用中央平台的條款及細則的承諾書」 (REO/C/10A/LC(SF)(2016))的正本以專人送遞或郵遞送交總選舉事 務主任(地址:九龍觀塘觀塘道 392 號創紀之城 6 期 23 樓 2301-03 室)。 候選人可在選舉事務處網頁下載最新版本的申請表:

候選人於 11 月 21 日共印刷 3,000 張傳單並於不同日期派發。假若候選人首次於 11 月 22 日於街頭派發有關傳單,並已於 11 月 23 日透過中央平台遞交選舉廣告詳情。惟候選人其後發現派發的傳單數量應為 800 張而非先前上載的 1,000 張,在此情況下,候選人須最遲於投票日後 2 個工作天內透過中央平台修正該選舉廣告詳情。候選人只須填寫須修改的項目,而無須重新填寫其他並無須要修正的項目。該修正資料應以下列表五方式填寫。

The candidate printed 3,000 copies of handbills in total on 21 November and they were first distributed on different dates. Assuming the candidate distributed them on 22 November, and he/she had submitted the EA particulars via Central Platform on 23 November. However, the candidate later found that the number of handbills distributed on the streets should be 800 instead of 1,000. In that case, the candidate had to correct such EA particulars via Central Platform not later than 2 working days after the polling day. The candidate should only fill in the information to be corrected and does not need to fill in other items which no correction is required. The correction should be done as shown in **Table 5** below.

The candidate printed 3,000 copies of handbills in total on 21 November and distributed 1,000 of them on the streets on 22 November. He/She had submitted the EA particulars via Central Platform on 23 November. However, the candidate later stated that the number of handbills distributed on the streets on 22 November should be 500 instead, and the remaining 500 were distributed on 24 November by post. In that case, the candidate should first correct on Central Platform the EA particulars distributed on 22 November by changing the number of handbills distributed on the streets from 1,000 to 500 (see **Table 7**). Regarding the 500 handbills distributed by post on 24 November, they should be regarded as a new EA as the handbills were distributed in a different manner. Instead of further correcting the EA particulars submitted previously, the candidate should in respect of such handbills that were distributed by post, submit by 25 November the new EA particulars and upload the sample of handbills sent by post via Central Platform. The new EA particulars should be filled in as shown in **Table 8** below.

候選於 11 月 21 製作了 10 張橫額,於 11 月 22 日懸掛於路邊鐵欄時沒有加上候選人編號。候 選人於 12 月 2 日於橫額貼上候選人編號標貼。在此情況下,候選人須於 11 月 23 日或之前將 選舉廣告詳情上載中央平台(見表九)。雖然候選人編號標貼本身不會被視為一份選舉廣告, 但由於候選人曾就原有的選舉廣告作出修改,候選人須最遲於投票日後2個工作天內透過中 央平台上載已貼上編號標貼的橫額樣本以修正已遞交的選舉廣告詳情。修正已遞交的選舉廣 告應以下列**表十**方式填寫。

The candidate produced 10 banners on 21 November and hanged the banners without candidate number on roadside railing on 22 November. The candidate stuck a candidate number sticker on the banners on 2 December. In this case, the candidate must submit the EA particulars onto the Central Platform by 23 November (See **Table 9**). Though the candidate number sticker is not an EA itself, the candidate should correct the EA particulars submitted previously not later than 2 working days after the polling day by uploading an EA sample with candidate number sticker on it as the original EA has been amended. The correction should be done as shown in **Table 10** below.

候選於 11 月 21 製作了 10 張只有候選人姓名及圖像的橫額,並於 11 月 22 日在街頭發布。候選人須於 11 月 23 日或之前透過中央平台上載選舉廣告詳情。候選人於 12 月 2 日於該橫額貼上新標語(例如「要求加密巴士班次」、「成功爭取增加斑馬線」等)。由於橫額所顯示的內容不同,該貼上標語的橫額應被視為一個新的選舉廣告。候選人應於 12 月 3 日或之前透過中央平台上載新的選舉廣告詳情及選舉廣告樣本,而不是修正之前發布的選舉廣告詳情。遞交新選舉廣告詳情應以下列表十一方式填寫。

The candidate produced 10 banners only with his/her name and image on it on 21 November and published the banner on 22 November. The candidate must submit the EA particulars via Central Platform by 23 November. The candidate later stuck new slogans on the banners on 2 December (e.g. "Request for increasing frequency of buses", "Successfully fight for additional zebra crossings" etc.). As the messages on the banners are different, the banners with new slogan should be regarded as new EAs. The candidate, instead of correcting the EA particulars submitted previously, should submit new EA particulars and new EA sample via Central Platform by 3 December. The new EA particulars should be filled in as shown in **Table 11** below.
