注意： 聯合選舉郵件內載有的選舉廣告很大可能意味着或導致選民相信發布選舉廣告的候選人獲得選舉廣告所提述其他候選人的支持。為符合《選舉（舞弊及非法行為）條例》（第554章）第27條的規定，候選人必須**事先向有關候選人取得書面同意支持**。就此，候選人應填寫“**支持同意書**”，並在投寄免費聯合選舉郵件**之前**向有關選舉主任繳存已填妥的同意書文本或將其上載至中央平台或候選人平台。

Remarks: The election advertisement contained in a joint election mail would very likely imply or cause electors to believe that the candidate publishing the election advertisement has the support of other candidate(s) mentioned in the election advertisement. the mail does not exceed 50 grams in weight;

the mail is not larger than 175 mm x 245 mm and not smaller than 90 mm x 140 mm in size;

The candidate posting the election mail shall be responsible for the election mail and its contents, and shall indemnify and keep indemnified the Electoral Affairs Commission and the Government against all liabilities, costs, expenses, actions, proceedings, claims, demands, losses and damages arising out of or in connection with the election mail and its contents; and
