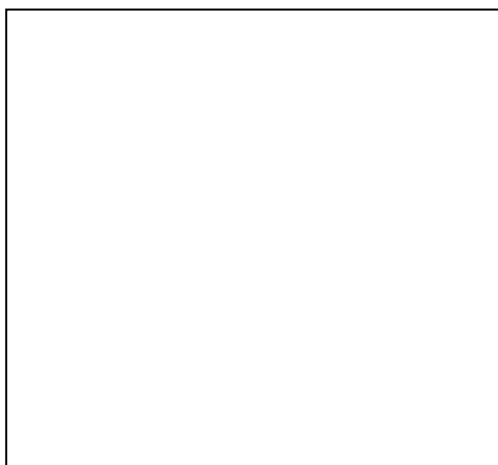

2. 根據《選舉管理委員會（選舉程序）（立法會）規例》（第 541D 章）第 104 條，“發布”是指印刷、展示、展覽、分發、張貼、公布或以任何其他方式使公眾獲知，並包括繼續發布。
According to section 104 of the Electoral Affairs Commission (Electoral Procedure) (Legislative Council) Regulation (Cap. 541D), “publish” means print, display, exhibit, distribute, post up, publicly announce or make publicly known by any other means, and includes continue to publish.

A witness can be any person aged 18 years or over and in possession of an identity document. According to section 3(1) of the Legislative Council Ordinance (Cap. 542), “identity document” (身分證明文件) means –
 - (a) 根據《人事登記條例》（第177章）向某人發出的身分證；或
an identity card issued to a person under the Registration of Persons Ordinance (Cap. 177); or
 - (b) 在根據該條例訂立並正有效的規例下向某人發出，並證明該人獲豁免而無須根據該條例登記的文件；或
a document issued to a person under regulations in force under that Ordinance certifying that the person is exempt from being required to register under that Ordinance; or
 - (c) 向某人發出的獲選舉登記主任接受為該人的身分證明的任何其他文件。
any other document issued to a person that is acceptable to the Electoral Registration Officer as proof of the person’s identity.
5. 根據《立法會選舉活動指引》第八章及《選舉管理委員會（選舉程序）（立法會）規例》（第 541D 章）第 105 條，候選人須在發布選舉廣告後的一個工作天內，把與選舉廣告有關的資料／文件，包括准許或同意書的電子文件，上載至中央平台或候選人平台或向選舉主任繳存印本式文本，以供公眾查閱。
In accordance with Chapter 8 of the “Guidelines on Election-related Activities in respect of the Legislative Council Election” and section 105 of the Electoral Affairs Commission (Electoral Procedure) (Legislative Council) Regulation (Cap. 541D), the candidate should, **within 1 working day** after publication of an election advertisement, post an electronic copy of the relevant information/document, including permission or consent, onto the Central Platform or Candidate’s Platform or deposit a hard copy with the Returning Officer for public inspection.

 - (a) **資料用途**
就此通知書提供的個人及其他有關的資料，會供選舉管理委員會、選舉事務處、有關的選舉主任及有關的政府部門用於與選舉有關的用途。
Purpose of Collection
The personal data and other related information supplied in connection with this notification will be used by the Electoral Affairs Commission, the Registration and Electoral Office, the relevant Returning Officer and other related government departments for election-related purposes.

(b) **資料轉介**

Transfer of Information

The personal data and other related information supplied in connection with this notification may also be provided to other authorised departments or persons including but not limited to the law courts for election-related purposes.

(c) **索閱個人資料**

Access to Personal Data

A person has the right to request access to and correction of the personal data he/she supplied in accordance with the provisions of the Personal Data (Privacy) Ordinance (Cap. 486).

(d) **個人資料保障原則**
