Notes on Completion of Notification of the Electronic Address of the Candidate's Platform

1. 為符合《選舉管理委員會(選舉程序)(區議會)規例》(第 541F章)第 106(2)條與選舉廣告有關的公眾查閱規定,"候選人平台"是指由候選人或獲其授權的人士所維持以供候選人在發布選舉廣告 後的 1 個工作天(即公眾假期及星期六以外的任何一天)內上載選舉廣告詳情予公眾查閱的公開平台。

To comply with the public inspection requirement governing election advertisements under section 106(2) of Electoral Affairs Commission (Electoral Procedure) (District Councils) Regulation (Cap. 541F), the "Candidate's Platform" refers to an open platform maintained by the candidate/a person authorised by the candidate which allows the candidate to post election advertisement particulars, within 1 working day (i.e. any day other than a general holiday and Saturday) after the publication of an election advertisement for public inspection.

In establishing a Candidate's Platform, the candidate must ensure that the platform complies with the rules and requirements as set out in section 106 of the Electoral Affairs Commission (Electoral Procedure) (District Councils) Regulation (Cap. 541F), and Chapter 7 and Appendix B of the "Guidelines on Election-related Activities in respect of the District Council Election". A proposed layout design of Candidate's Platform is attached for ease of reference (see Annex).

- 4. 候選人須確保候選人平台繼續運作直至選舉申報書的文本根據《選舉(舞弊及非法行為)條例》(第 554章)第 41 條可供查閱的期間結束為止,以便公眾查閱選舉廣告。
 - Candidate must ensure his/her Candidate's Platform continues to operate until the end of the period for which copies of election returns are available for inspection pursuant to section 41 of the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554) to facilitate public inspection of the election advertisements.
