Notes on Completion of Advance Return and Declaration of Election Donations

Please read the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554) and Chapter 15 of the "Guidelines on Election-related Activities in respect of the District Council Election" issued by the Electoral Affairs Commission before completing this return and declaration.

- (c) any service provided to or in respect of the candidate for the purpose of promoting the election of the candidate or of prejudicing the election of another candidate or other candidates, but does not include voluntary service.
