I hereby declare and understand that:

(a) 郵件只載有與候選人參選這次補選相關的物料; the mail contains materials relating only to the candidature of the candidate at this by-election;

- (b) 郵件重量不超逾 50 克; the mail does not exceed 50 grams in weight;

The candidate posting the election mail shall be responsible for the election mail and its contents, and shall indemnify and keep indemnified the Electoral Affairs Commission and the Government against all liabilities, costs, expenses, actions, proceedings, claims, demands, losses and damages arising out of or in connection with the election mail and its contents.
