**Notes on Completion of Application for Creating an Account of the Central Platform and
Undertaking in respect of the Terms and Conditions in Using the Central Platform for Candidates**

1. 為符合《選舉管理委員會（選舉程序）（立法會）規例》（第 541D 章）第 105(2) 條與選舉廣告有關的公眾查閱規定，“中央平台”是指一個由總選舉事務主任或獲其授權的人士所維持以供候選人在發布選舉廣告後的 1 個工作天（即公眾假期及星期六以外的任何一天）內上載選舉廣告詳情予公眾查閱的公開平台。候選人必須確保上載的選舉廣告詳情符合《選舉管理委員會（選舉程序）（立法會）規例》（第 541D 章）第 105 條及《立法會選舉活動指引》第八章及附錄五的規定及要求。
To comply with the public inspection requirement governing EAs under section 105(2) of the Electoral Affairs Commission (Electoral Procedure) (Legislative Council) Regulation (Cap. 541D), the “Central Platform” refers to an open platform maintained by the CEO or a person authorised by him/her which allows a candidate to upload EA particulars, **within 1 working day (i.e. any day other than a general holiday and Saturday) after the publication of an EA** for public inspection. The candidate must ensure that the EA particulars uploaded comply with the rules and requirements as set out in section 105 of the Electoral Affairs Commission (Electoral Procedure) (Legislative Council) Regulation (Cap. 541D), and Chapter 8 and Appendix 5 of the “Guidelines on Election-related Activities in respect of the Legislative Council Election”.
