Notes on Completion of Notification of the Electronic Address of the Candidate's Platform

1. 為符合《選舉管理委員會（選舉程序）（立法會）規例》（第 541D 章）第 105(2) 條與選舉廣告有關的公眾查閱規定，“候選人平台”是指由候選人或獲其授權的人士所維持以供候選人在發布選舉廣告後的 1 個工作天（即公眾假期及星期六以外的任何一天）內上載選舉廣告詳情予公眾查閱的公開平台。

To comply with the public inspection requirement governing election advertisements under section 105(2) of the Electoral Affairs Commission (Electoral Procedure) (Legislative Council) Regulation (Cap. 541D), the “Candidate’s Platform” refers to an open platform maintained by the candidate/a person authorised by the candidate which allows the candidate to upload election advertisement particulars, **within 1 working day (i.e. any day other than a general holiday and Saturday) after the publication of an election advertisement** for public inspection.

2. 候選人須於此通知書第一或第二部分以中文及英文提供他／她／他們的姓名，以便在中央平台上顯示候選人的資料。如此通知書第一部分由候選人的選舉代理人填寫，候選人必須填寫及簽署此通知書第二部分。如屬地方選區／區議會（第二）功能界別候選人名單，該名單上所有候選人必須填寫及簽署本通知書的第二部分。

Candidate(s) should provide his/her/their name(s) in both Chinese and English in Part I or II of this notification so as to display the information of candidate(s) at the Central Platform. If Part I of this notification is filled in by the election agent of the candidate(s), the candidate(s) has/have to complete and sign Part II of this notification. For a geographical constituency/District Council (second) functional constituency list of candidates, all candidates on the list must complete and sign Part II of this notification.

3. 若候選人選擇自行維持一個平台以上載其選舉廣告詳情供公眾查閱，他／她／他們必須在發布首個選舉廣告的最少 3 個工作天前，向總選舉事務主任提供該平台的電子地址。就候選人名單而言，該平台的電子地址應由其選舉代理人或名單上任何一位候選人代同一份名單上其他候選人向總選舉事務主任提交。在建立候選人平台時，候選人亦須確保該平台符合《選舉管理委員會（選舉程序）（立法會）規例》（第 541D 章）第 105 條及《立法會選舉活動指引》第八章及附錄五的規定及要求。現夾附候選人平台建議版面設計（見附件），以供參閱。

If candidate(s) choose(s) to maintain a platform of his/her/their own for the posting of election advertisement particulars for public inspection, he/she/they must provide the electronic address of the platform to the Chief Electoral Officer **at least 3 working days before** publication of the first election advertisement. For a list of candidates, the election agent or any candidate on the list on behalf of other candidates on the same list may provide the electronic address of the platform to the Chief Electoral Officer. In establishing a Candidate’s Platform, candidate(s) must ensure that the platform complies with the rules and requirements as set out in section 105 of the Electoral Affairs Commission (Electoral Procedure) (Legislative Council) Regulation (Cap. 541D), and Chapter 8 and Appendix 5 of the “Guidelines on Election-related Activities in respect of the Legislative Council Election”. A proposed layout design of Candidate’s Platform is attached for ease of reference (see Annex).

4. 候選人須確保他／她／他們的候選人平台繼續運作直至選舉申報書的文本根據《選舉（舞弊及非法行為）條例》（第 554 章）第 41 條可供查閱的期間結束為止，以便公眾查閱選舉廣告。

Candidate(s) must ensure his/her/their Candidate’s Platform continues to operate until the end of the period for which copies of election returns are available for inspection pursuant to section 41 of the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554) to facilitate public inspection of the election advertisements.

5. 候選人在候選人平台中載有已發布之選舉廣告所招致的所有選舉開支，須在「選舉開支及接受選舉捐贈之申報書及聲明書」內申報。

All election expenses incurred for the published election advertisements contained in the Candidate’s Platform must be declared in the “Return and Declaration of Election Expenses and Election Donations”.
