# Notes on Completion of Consent of Support Given by Individual(s) in Personal Capacity or Official Capacity

1. 在《選舉(舞弊及非法行為)條例》(第554章)第27條中,"支持"就某候選人而言,包括對該候選人的政策或活動的支持。

In section 27 of Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554), "support", in relation to a candidate, includes support for the policies or activities of the candidate.

2. 根據《立法會選舉活動指引》第八章及《選舉管理委員會(選舉程序)(立法會)規例》(第 541D 章)第 105 條,候選人須在發布選舉廣告後的一個工作天<u>(即公眾假期及星期六以外的任何一天)</u>內,把與選舉廣告有關的資料/文件,包括准許或同意書的電子文本,上載至中央平台或候選人平台或向選舉主任繳存印本式文本,以供公眾香閱。

In accordance with Chapter 8 of the "Guidelines on Election-related Activities in respect of the Legislative Council Election" and section 105 of the Electoral Affairs Commission (Electoral Procedure) (Legislative Council) Regulation (Cap. 541D), the candidate should, within 1 working day (i.e. any day other than a general holiday and Saturday) after publication of an election advertisement, upload an electronic copy of the relevant information/document, including permission or consent, onto the Central Platform or Candidate's Platform or deposit a hard copy with the Returning Officer for public inspection.

- 3. 如向地方選區或區議會(第二)界別選舉某份候選人名單上的候選人發出書面同意,請列出名單上的所有候選人的姓名;否則,應分別填寫此表格向每位候選人發出一份獨立的支持同意書。
  - If a written consent is given to the candidates on a list of candidates in a geographical constituency or District Council (second) functional constituency election, please set out the names of all candidates on the list. According to Chapter 18 of the "Guidelines on Election-related Activities in respect of the Legislative Council Election", if a written consent is given by the supporter in his/her personal capacity to a candidate/ list of candidates, no reference should be made to any office title which he/she may have in the candidate's/list of candidates' election advertisements.

In the case where an office-bearer of an organisation wishes to use his/her office title to support a candidate/list of candidates, that supporter must complete item 2 or items 2 and 3 of this Consent of Support as appropriate, depending on the following situations –

# A supporter with the reference to his/her office title (bearing no reference to the name of the organisation concerned)

In this case, the Consent of Support should indicate whether the supporter consents to the mention of his/her office title(s) and the description of such title(s). Where such office title(s) is/are to be referred to in an election advertisement, the supporter and the candidate/list of candidates should take particular care to ensure that the information should not be used in such a way to misrepresent the support of the organisation concerned.

#### A supporter with the reference to his/her office title and the name of the organisation concerned

In this case, the candidate/list of candidates should ensure that the supporter has obtained the prior written approval of the organisation, in accordance with the organisation's internal rules and procedures or any established convention (e.g. approved by the governing body of the organisation or by a resolution of that organisation passed at a general meeting), for using the name of the organisation together with the supporter's

office title(s) by the candidate(s). In case of doubt, the candidate/list of candidates or his/her/their supporter should consult the organisation concerned on its internal rules and procedures. The candidate/list of candidates should be careful not to give the impression that the whole organisation supports that candidate/list of candidates.

- 6. 任何年滿 18 歲並持有身分證明文件的人士,均可擔任見證人。 A witness can be any person aged 18 years or over and in possession of an identity document.
- 7. 給予同意的人士可夾附一份附錄,以載述所同意的詳情或選舉廣告內容或修改詳情。候選人在未取得有關人士事先的書面同意下修改或授權他人修改該等姓名、標識或圖像或選舉廣告內容,即屬在選舉中作出非法行為,違反《選舉(舞弊及非法行為)條例》(第 554 章)第 27 條。若修改姓名、標識或圖像或選舉廣告內容可致有關人士的個人資料不準確,候選人亦會違反《個人資料(私隱)條例》(第 486 章)附表 1 的保障資料第 2(1)原則。 Individual giving consent may attach an Appendix showing the details of the consent or content of the election advertisement or the details of modification. A candidate engages in illegal conduct contrary to section 27 of the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554) if he/she modifies or authorises any person to modify the name, logo or pictorial representation or the content of the election advertisement without prior written consent by the individual. If the modification of name, logo or pictorial representation or the content of the election advertisement may render the relevant individual's personal data inaccurate, the candidate will also contravene the Data Protection Principle 2(1) in Schedule 1 to the Personal Data (Privacy) Ordinance (Cap. 486).
- 8. 當支持同意被撤銷後,候選人應立即停止使用任何載有已撤銷同意的人士所表示支持的選舉廣告,並即時銷毀取得的有關個人資料。

Once consent has been revoked, a candidate should cease immediately using any election advertisement which contains the support of the person who has made the revocation. The relevant personal data collected should also be destroyed immediately.

#### (a) 資料用途

就此支持同意書提供的個人及其他有關的資料,會供選舉管理委員會、選舉事務處、有關的選舉主任及有關的政府部門用於與選舉有關的用途。

#### **Purpose of Collection**

The personal data and other related information supplied in connection with this Consent of Support will be used by the Electoral Affairs Commission, the Registration and Electoral Office, the relevant Returning Officer and related government departments for election-related purposes.

#### (b) **資料轉**介

支持同意書會供公眾查閱直至選舉申報書的文本根據《選舉(舞弊及非法行為)條例》(第554章)第41條可供查閱的期間結束為止。就此支持同意書提供的個人及其他有關的資料亦可能會提供予其他獲授權的部門或人士,包括但不限於法院,用於與選舉有關的用途。

#### **Transfer of Information**

The Consent of Support will be made available for public inspection until the end of the period for which copies of election returns are available for inspection pursuant to section 41 of the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554). The personal data and other related information supplied in connection with this Consent of Support may also be provided to other authorised departments or persons, including but not limited to the law courts for election-related purposes.

#### (c) <u>索閱個人資料</u>

任何人有權根據《個人資料(私隱)條例》(第486章)的條文要求索閱及改正他/她所提供的個人資料。

### Access to Personal Data

Any person has the right to request access to and correction of the personal data which he/she supplied in accordance with the provisions of the Personal Data (Privacy) Ordinance (Cap. 486).

#### (d) 個人資料保障原則

候選人及代理人在收集第三者的個人資料以填寫此支持同意書時,須遵守《個人資料(私隱)條例》(第486章)附表 1 的保障資料原則,特別是第2和第4原則,即採取所有切實可行的步驟,以確保(1)持有的個人資料準確無誤,而資料的保存時間不應超過達致原來目的的實際所需;及(2)個人資料受到保障而不受未獲准許的或意外的查閱、處理、刪除、喪失或使用。

#### **Personal Data Protection Principles**

Candidates and agents are reminded to observe the Data Protection Principles in Schedule 1 to the Personal Data (Privacy) Ordinance (Cap. 486) in collecting personal data of a third person in completing this Consent of Support, in particular Principles 2 and 4 concerning the requirement to take all practicable steps to ensure that (1) personal data is accurate and will not be kept longer than is necessary to fulfil the purpose for which it is used; and (2) personal data are protected against unauthorised or accidental access, processing, erasure, loss or use.
