注意: 聯合選舉郵件內載有的選舉廣告很大可能意味着或導致選民相信發布選舉廣告的候選人獲得選舉廣告所提述其他候選人的支持。為符合《選舉(舞弊及非法行為)條例》(第554章)第27條的規定,候選人必須**事先向有關候選人取得書面同意支持**。就此,候選人應填寫 "支持同意書",並在投寄免費聯合選舉郵件之前向有關選舉主任繳存已填妥的同意書文本或將其上載至中央平台或候選人平台。

Remarks: The election advertisement contained in a joint election mail would very likely imply or cause electors to believe that the candidate publishing the election advertisement has the support of other candidate(s) mentioned in the election advertisement. In order to comply with section 27 of the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554), prior written consent of support must be obtained from the relevant candidate(s). In this regard, candidate(s) should complete the "Consent of Support" and deposit a copy of it with the relevant Returning Officer or upload it to the Central Platform or Candidate's Platform before posting a joint election mail free of postage.

I hereby declare and understand that:

- (a) 郵件只載有與本通知書所提述的候選人參選上述選舉相關的物料;
  the mail contains materials relating only to the candidature of the candidate(s) mentioned in this Notice at the above election;
- (b) 每封郵件重量不超逾 50 克;
  - each mail does not exceed 50 grams in weight;
- (c) 每封郵件尺碼不大於 165 毫米乘以 245 毫米,但不小於 90 毫米乘以 140 毫米; each mail is not larger than 165 mm x 245 mm and not smaller than 90 mm x 140 mm in size;
- (d) 每封郵件厚度不超逾5毫米;
  - each mail does not exceed 5 mm in thickness;
- (e) 郵件不含有任何淫褻、不道德、不雅、令人反感或帶永久形式誹謗的文字、圖片或其他東西;
  - the mail does not contain any obscene, immoral, indecent, offensive or libelous writing, picture or other thing;
- (f) 如果選舉郵件中收納了某人士或組織的姓名、名稱、標識或圖像(視屬何情況而定),而發布的方式意味着或相當可能導致選民相信本通知書所提述的候選人已獲得該人或該組織的支持,候選人均已事先取得該人或該組織的書面同意;

if the name, logo or pictorial representation of a person or an organisation (as the case may be) is included in the election mail, and the publication is in such a way as to imply or to be likely to cause electors to believe that the candidate(s) mentioned in this Notice has/have the support of that person or organisation, the candidate(s) has/have obtained prior written consent from that person or organisation;

- (g) 樣本內容完全符合所有適用的法律及《立法會選舉活動指引》;
  - the contents of the specimens are in full compliance with all applicable laws and the "Guidelines on Election-related Activities in respect of the Legislative Council Election";
- (h) 如附上的選舉郵件樣本內容含有中文及英文以外的語言,我現附上該部份內容的\*中文/英文翻譯,以確保其符合本 聲明;
  - if the enclosed specimens of the election mail contain any content in a language other than Chinese and English, I hereby enclose the \*Chinese/English translation of such content in order to ensure it complies with this declaration;
- (i) 選舉管理委員會及香港特別行政區政府(包括香港郵政及選舉事務處)對候選人及任何第三者概不就選舉郵件承擔任何責任,包括但不限於因選舉郵件內容的任何錯誤、遺漏、虛假或具誤導性的陳述而引致的責任。投寄選舉郵件的候選人必須為選舉郵件及其內容承擔一切責任,並須就選舉郵件及其內容所引致或涉及的一切責任、費用、開支、法律行動、法律程序、申索、要求、損失及損害賠償,向選舉管理委員會及政府作出彌償,並保持令其獲得彌償;及
  - the Electoral Affairs Commission and the Government of the Hong Kong Special Administrative Region (including Hongkong Post and the Registration and Electoral Office) shall not be responsible to the candidate(s) and any third party for the election mail, including but not limited to any liabilities arising from any errors in, omissions from, false or misleading statements in the contents of the election mail. The candidate posting the election mail shall be responsible for the election mail and its contents, and shall indemnify and keep indemnified the Electoral Affairs Commission and the Government against all liabilities, costs, expenses, legal actions, legal proceedings, claims, demands, losses and damages arising out of or in connection with the election mail and its contents; and

1. 為確保香港郵政可於截郵限期(即2020年8月14日)前批准選舉郵件樣本,候選人/選舉代理人最遲須於2020年8月11日提交最終樣本予香港郵政。請注意,由於香港郵政需在短時間內處理大量郵件,在截郵限期後投寄的郵件很可能無法在投票日前寄達選民。

In order to ensure that Hongkong Post could approve all specimens of election mail before the posting deadline (i.e., 14 August 2020), candidates/election agents should submit the final specimens to Hongkong Post by 11 August 2020 the latest. Please note that since Hongkong Post needs to handle a large volume of mail within this short period of time, mail posted after the posting deadline is unlikely to reach the electors before the polling day.

### (a) <u>資料用途</u>

就此通知書提供的個人及其他有關的資料,會供香港郵政、選舉管理委員會、選舉事務處、有關的選舉主任及其他有關的政府部門用於與選舉有關的用途。

#### Purpose of Collection

The personal data and other related information supplied in connection with this notice will be used by Hongkong Post, the Electoral Affairs Commission, the Registration and Electoral Office, the relevant Returning Officer(s) and other related government departments for election-related purposes.

### (b) 資料轉介

就此通知書提供的個人及其他有關的資料可能會提供予其他獲授權的部門或人士,包括但不限於法院,用於與選舉有關的用途。

#### Transfer of Information

The personal data and other related information supplied in connection with this notice may be provided to other authorised departments or persons, including but not limited to the law courts for election-related purposes.

### (c) <u>索閱個人資料</u>

任何人有權根據《個人資料(私隱)條例》(第 486 章)的條文要求索閱及改正他她所提供的個人資料。

#### Access to Personal Data

Any person has the right to request access to and correction of the personal data he/she supplied in accordance with the provisions of the Personal Data (Privacy) Ordinance (Cap. 486).

#### (d) 香詢
