Purpose of Collection

The personal data and other related information supplied in connection with this declaration will be used by Hongkong Post, the Electoral Affairs Commission, the Registration and Electoral Office, the relevant Returning Officer(s) and other related government departments for election-related purposes.

(b) 資料轉介

Transfer of Information

The personal data and other related information supplied in connection with this declaration may be provided to other authorised departments or persons, including but not limited to the law courts for election-related purposes.

Access to Personal Data

Any person has the right to request access to and correction of the personal data he/she supplied in accordance with the provisions of the Personal Data (Privacy) Ordinance (Cap. 486).
