- (c) 干擾或企圖干擾任何投票箱、選票結算表、選票結算核實書或覆核書、或其他有關的選舉物料；或 interfere with or attempt to interfere with any ballot boxes, ballot paper accounts, verifications or re-verifications of such accounts or other relevant election materials; or

- (d) 在點票過程拍影片、拍照、錄音或錄影。

If *I am/we are so removed, *I/we may not re-enter the counting station except with the permission of the Chief Returning Officer or the relevant Returning Officer.

Notes on Completion of Notice of Appointment of Counting Agents for a Functional Constituency (other than the District Council (second) Functional Constituency)

1. 除非候選人以指明表格明文另作示明，有關代理人須當作是為在預定日期進行的投票中和（如適用的話）於遭押後的該次投票中所投的票的點算而委任。
The agent is to be regarded as being appointed for the counting of the votes cast in the poll to be conducted on the scheduled date and (where applicable) the postponed or adjourned poll, unless the candidate expressly indicates otherwise in the specified form.
2. 功能界別的點票工作會於中央點票站進行。每名功能界別候選人（區議會（第二）功能界別除外）或其選舉代理人可就在該候選人獲提名的功能界別委任不超過 5 名監察點票代理人。凡年滿 18 歲的香港身分證持有人均可被委任為監察點票代理人。候選人或其選舉代理人不應委任任何總選舉主任、選舉主任、助理選舉主任、或任何已受總選舉事務主任委任協助進行投票或點票的人士（通常為政府公職人員）為其監察點票代理人。
Counting of votes for functional constituencies will be conducted in the central counting station. Each functional constituency candidate or his/her election agent may appoint not more than 5 counting agents in respect of the functional constituency (other than the District Council (second) Functional Constituency) for which the candidate is nominated. Any person who is a holder of a Hong Kong Identity Card and has attained the age of 18 years may be appointed as a counting agent. However, a candidate or his/her election agent should not appoint any Chief Returning Officer, Returning Officer, Assistant Returning Officer, or any person (usually a government officer) already appointed by the Chief Electoral Officer to assist at the poll or at the count as his/her counting agent.
3. 此通知書的第一部分應由候選人或其選舉代理人填寫及簽署。第二部分應由各個監察點票代理人填寫及簽署。
PART I of this notice should be completed and signed by the candidate or the election agent of the candidate. PART II should be completed and signed by each of the counting agents.
4. 監察點票代理人的委任通知書須於投票日前的第 7 天或之前（即 2020 年 8 月 30 日或之前）藉專人送遞、郵遞、電子郵件或圖文傳真方式交付予有關的選舉主任，或於投票日由候選人或選舉代理人親自交付予有關的選舉主任。逾期遞交的通知將不予接納。監察點票代理人的委任，在選舉主任接獲委任通知書後始生效。
Notice of appointment of counting agents must either be delivered to the relevant Returning Officer by hand, by post, by electronic mail or by facsimile transmission at least 7 days before the polling day (i.e. on or before 30 August 2020), or be delivered by the candidate or the election agent in person to the relevant Returning Officer on the polling day. Late submissions will not be accepted. The appointment of counting agents will not be effective until the notice of appointment is received by the Returning Officer.

Access to Personal Data

Any person has the right to request access to and correction of the personal data he/she supplied in accordance with the provisions of the Personal Data (Privacy) Ordinance (Cap. 486).

(d) **個人資料保障原則**

Personal Data Protection Principles

Candidates/Election agents are reminded to observe the Data Protection Principles in Schedule 1 to the Personal Data (Privacy) Ordinance (Cap. 486) in collecting personal data of a third person in completing this notice, in particular Principle 4 concerning the requirement to take all practicable steps to ensure that personal data are protected against unauthorised or accidental access, processing, erasure, loss or use.
