Notes on Completion of Notice of Revocation of Appointment of Agent

Candidate(s) may revoke the appointment of any type of agent at any time. An election agent may only revoke the appointment of a polling agent or a counting agent. In case of a geographical constituency/District Council (second) functional constituency list of candidates, the notice must be signed by all candidate(s) on the list or the election agent of the list. In addition, this notice may be given by one of the candidates on the list or the election agent of the list.
