1. 為確保香港郵政可於截郵限期(即 2021 年 12 月 3 日)前處理所有選舉郵件樣本,候選人/選舉代理人最遲須於 2021 年 11 月 30 日提交最終樣本予香港郵政。請注意,由於香港郵政需在短時間內處理大量選舉郵件,在截郵限期後投寄 的選舉郵件很可能無法在投票日前寄達選民。

In order to ensure that Hongkong Post could process all specimens of election mail before the posting deadline (i.e., 3 December 2021), candidates/election agents should submit the final specimens to Hongkong Post by 30 November 2021 the latest. Please note that since Hongkong Post needs to handle a large volume of election mail within a short period of time, election mail posted after the posting deadline will unlikely reach the electors before the polling day.
