\*I/Each of us also understand(s) that if \*I/we misconduct \*myself/ourselves or behave in a disorderly manner at or in the vicinity of the counting station/ballot paper sorting station, or fail to obey any lawful order of the Chief Returning Officer, the relevant Returning Officer or the Presiding Officer, \*I/we shall commit an offence punishable with a fine and imprisonment and may be ordered by the Chief Returning Officer, the relevant Returning Officer or the Presiding Officer to leave the area immediately. \*My/Our failure to leave the area may result in \*my/our being removed by a police officer or person authorized in writing by the Chief Returning Officer, the relevant Returning Officer or the Presiding Officer (as may be appropriate). If \*I am/we are so removed, \*I/we may not re-enter the counting station/ballot paper sorting station except with the permission of the Chief Returning Officer, the relevant Returning Officer or the Presiding Officer.

# 填寫地方選區監察點票代理人委任通知書說明

## Notes on Completion of Notice of Appointment of Counting Agents for a Geographical Constituency

1. 除非候選人以指明表格明文另作示明，有關代理人須當作是為在預定日期進行的投票中和（如適用的話）於遭押後的該次投票中所投的票的點算而委任。

The relevant agent is to be regarded as being appointed for the counting of the votes cast in the poll to be conducted on the scheduled date and (where applicable) the postponed or adjourned poll, unless the candidate(s) expressly indicate(s) otherwise in the specified form.

2. 每名地方選區候選人或其選舉代理人可就中央點票站、每個點票分流站及在該候選人獲提名的地方選區內每個點票站各委任不超過 2 名監察點票代理人。凡年滿 18 歲的香港身分證持有人均可被委任為監察點票代理人。候選人或其選舉代理人不應委任總選舉主任、任何選舉主任、助理選舉主任、或任何已受總選舉事務主任委任協助進行投票或點票的人士為其監察點票代理人。

Each geographical constituency candidate or his/her election agent may appoint not more than 2 counting agents for the central counting station, each ballot paper sorting station and each counting station in respect of the geographical constituency for which the candidate is nominated. Any person who is a holder of a Hong Kong Identity Card and has attained the age of 18 years may be appointed as a counting agent. A candidate or his/her election agent should not appoint the Chief Returning Officer, any Returning Officer, Assistant Returning Officer, or any person already appointed by the Chief Electoral Officer to assist at the poll or at the count as his/her counting agent.

3. 此通知書的第一部分應由候選人或其選舉代理人填寫及簽署。第二部分應由各個監察點票代理人填寫及簽署。

PART I of this notice should be completed and signed by the candidate or his/her election agent. PART II should be completed and signed by each of the counting agents.

4. 填妥的監察點票代理人的委任通知書須於投票日前的第 7 天或之前（即 2021 年 12 月 12 日或之前）藉專人送遞、郵遞、電子郵件或圖文傳真方式交付予有關的選舉主任，或於投票日由候選人或其選舉代理人親自交付予監察點票代理人所負責的點票站／選票分流站的投票站主任（如該等監察點票代理人所負責的是中央點票站，則須送交有關的選舉主任）。逾期遞交的通知書將不予接納。監察點票代理人的委任，在有關的選舉主任或投票站主任（視何者屬適當而定）接獲委任通知書後始生效。

The duly completed notice of appointment of counting agents must be delivered to the relevant Returning Officer by hand, by post, by electronic mail or by facsimile transmission at least 7 days before the polling day (i.e. on or before 12 December 2021), or be delivered by the candidate or his/her election agent in person to the Presiding Officer for the counting station/ballot paper sorting station for which the counting agents are appointed on the polling day (or to the relevant Returning Officer if the counting agents are appointed for the central counting station). Late submissions will not be accepted. The appointment of counting agents will not be effective until the notice of appointment is received by the relevant Returning Officer or the Presiding Officer (as may be appropriate).

(a) **資料用途**

就此通知書提供的個人及其他有關的資料，會供選舉管理委員會、選舉事務處、總選舉主任、有關的選舉主任及有關投票站／點票站／選票分流站的投票站主任及有關的政府部門用於與選舉有關的用途。

**Purpose of Collection**

The personal data and other related information supplied in connection with this notice will be used by the Electoral Affairs Commission, the Registration and Electoral Office, the Chief Returning Officer, the relevant Returning Officer and the Presiding Officers for the relevant polling stations/counting stations/ballot paper sorting stations and related government departments for election-related purposes.

(b) **資料轉介**

就此通知書提供的個人及其他有關的資料可能會提供予其他獲授權的部門或人士，包括但不限於法院，用於與選舉有關的用途。

**Transfer of Information**

The personal data and other related information supplied in connection with this notice may be provided to other authorized departments or persons, including but not limited to law courts for election-related purposes.

(c) **索閱個人資料**

任何人有權根據《個人資料（私隱）條例》（第 486 章）的條文要求索閱及改正他／她所提供的個人資料。

**Access to Personal Data**

Any person has the right to request access to and correction of the personal data he/she supplied in accordance with the provisions of the Personal Data (Privacy) Ordinance (Cap. 486).

(d) **個人資料保障原則**

候選人／選舉代理人應留意，在收集第三者的個人資料以填寫此通知書時，須遵守《個人資料（私隱）條例》（第 486 章）附表 1 的保障資料原則，特別是第 4 原則，即採取所有切實可行的步驟，以確保個人資料受到保障而不受未獲准許的或意外的查閱、處理、刪除、喪失或使用。

**Personal Data Protection Principles**

Candidates/Election agents are reminded to observe the Data Protection Principles in Schedule 1 to the Personal Data (Privacy) Ordinance (Cap. 486) in collecting personal data of a third person in completing this notice, in particular Principle 4 concerning the requirement to take all practicable steps to ensure that personal data are protected against unauthorized or accidental access, processing, erasure, loss or use.
