### (1) 選舉捐贈之處置

#### DISPOSAL OF ELECTION DONATIONS

倘若所有選舉捐贈的總額超出在選舉中可由候選人或由他人代候選人招致的選舉開支最高限額,或在 選舉後全部或部分捐贈尚未用於償付或分擔償付該候選人的選舉開支;或(如該項捐贈包含貨品)促使該 候選人當選或阻礙另一名候選人或另一些候選人當選,候選人必須確保將超額或未動用的選舉捐贈(不包 括屬服務性質的選舉捐贈),給予該候選人所選擇的屬公共性質的慈善機構或慈善信託。

If the aggregate of all election donations given to or for a particular candidate exceeds the maximum amount of election expenses that can be incurred by or on behalf of the candidate at an election, or remains unused in whole or in part after the election for the purpose of meeting, or contributing towards meeting, the election expenses of the candidate; or in the case of an election donation consisting of goods, for the purpose of promoting the election of the candidate or of prejudicing the election of another candidate or other candidates, the candidate must ensure that the excess or unused election donation (not including election donations of services) is given to a charitable institution or trust of a public character chosen by the candidate.

#### ARRANGEMENT FOR PUBLIC INSPECTION

候選人會在其「接受選舉捐贈預先申報書及聲明書」(如適用)及「選舉開支及接受選舉捐贈之申報書及聲明書」內填報列載於此收據的捐贈者的姓名或名稱及地址。捐贈者可選擇披露其屬意的地址,如其辦事處或業務地址、通訊地址、住址或郵政信箱號碼。申報書及聲明書以及此收據副本將備存於選舉事務處,由有關文件提交總選舉事務主任的時間起,直至根據《選舉(舞弊及非法行為)條例》(第 554 章)第 41 條規定選舉申報書可供公眾查閱的期間完結為止,供公眾查閱或提供予索閱有關文件的人士,而申報書及聲明書以及此收據副本內的捐贈者的姓名或名稱及地址不會被遮蓋(見說明第 4 項)。

The candidate will enter in his/her "Advance Return and Declaration of Election Donations" (if applicable) and "Return and Declaration of Election Expenses and Election Donations" the name and address of the donor provided in this receipt. The donor may choose to disclose an address that he/she/it prefers, for example his/her/its office or business address, correspondence address, residential address or post office box number. Copies of the return and declaration and this receipt will be kept at the Registration and Electoral Office and made available for public inspection or may be furnished to any person requesting for the relevant document from the time when the relevant documents are lodged with the Chief Electoral Officer until the end of the period for which copies of election returns are available for public inspection under section 41 of the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554), and the name and address of the donor in copies of the return and declaration and this receipt will not be covered (see Note 4).

## **Notes on Completion of Standard Receipt for Election Donations**

1. 當收取每項價值1,000元以上的選舉捐贈(不論是以金錢、貨品或服務形式抵付)時,候選人必須向捐贈者發出收據,載明捐贈者的姓名或名稱及地址(一如捐贈者所提供的資料)及該項選舉捐贈的詳情。捐贈者可選擇披露其屬意的地址,如其辦事處或業務地址、通訊地址、住址或郵政信箱號碼。

On receiving each election donation (whether by way of money, goods or service) of more than \$1,000 in value, candidate must issue to the donor a receipt which specifies the name and address of the donor (as supplied by the donor) and the particulars of such election donation. The donor may choose to disclose an address that he/she/it prefers, for example his/her/its office or business address, correspondence address, residential address or post office box number.

2. 選舉捐贈收據的正本應交予有關的捐贈者,其副本由候選人保存作記錄。

The original of the receipt for the election donation should be given to the donor concerned, and a copy of it should be kept by the candidate for record.

3. 候選人應另製備選舉捐贈收據的副本,以便連同「接受選舉捐贈預先申報書及聲明書」(表格編號: REO/C/16/2021ECSSE(SDF))(如適用)及「選舉開支及接受選舉捐贈之申報書及聲明書」(表格編號: REO/C/1/2021ECSSE(SF))一併向總選舉事務主任提交。

Candidate should make copies of receipts for election donations to be lodged with the Chief Electoral Officer together with "Advance Return and Declaration of Election Donations" (Form no.: REO/C/16/2021ECSSE(SDF)) (if applicable) and "Return and Declaration of Election Expenses and Election Donations" (Form no.: REO/C/1/2021ECSSE(SF)).

4. 請注意下列有關在此選舉捐贈收據提供個人資料的說明-

Please note the following with regard to the personal data supplied in connection with this receipt for election donations -

## (a) 資料用途

就此選舉捐贈收據提供的個人及其他有關的資料,會供選舉管理委員會、選舉事務處、有關的選舉主任及其他有關的政府部門用於與選舉有關的用途。

## **Purpose of Collection**

The personal data and other related information supplied in connection with this receipt for election donations will be used by the Electoral Affairs Commission, the Registration and Electoral Office, the relevant Returning Officer and other related government departments for election-related purposes.

#### (b) 資料轉介

此選舉捐贈收據連同所有附件的副本會供公眾查閱。在展示前,此選舉捐贈收據連同所有附件內所有個人資料(捐贈者的姓名及地址除外)將會被遮蓋。就此選舉捐贈收據提供的個人及其他有關的資料亦可能會提供予其他獲授權的部門或人士,包括但不限於法院,用於與選舉有關的用途。

#### **Transfer of Information**

A copy of this receipt for election donations and all attachments will be made available for public inspection. All personal data (except the name and address of the donor) in this receipt for election donations and all attachments will be covered before display. The personal data and other related information supplied in connection with this receipt for election donations may also be provided to other authorized departments or persons, including but not limited to the law courts for election-related purposes.

## (c) <u>索閱個人資料</u>

任何人有權根據《個人資料(私隱)條例》(第 486 章)的條文要求索閱及改正他/她在此選舉捐贈收據所提供的個人資料。

#### **Access to Personal Data**

Any person has the right to request access to and correction of the personal data he/she supplied in this receipt for election donations in accordance with the provisions of the Personal Data (Privacy) Ordinance (Cap. 486).

#### (d) <u>個人資料保障原則</u>

候選人應留意,在收集第三者的個人資料以填寫此選舉捐贈收據時,須遵守《個人資料(私隱)條例》(第486章)附表1的保障資料原則,特別是第4原則,即採取所有切實可行的步驟,以確保個人資料受到保障而不受未獲准許的或意外的查閱、處理、刪除、喪失或使用。

## **Personal Data Protection Principles**

Candidates are reminded to observe the Data Protection Principles in Schedule 1 to the Personal Data (Privacy) Ordinance (Cap. 486) in collecting personal data of a third person in completing this receipt for election donations, in particular Principle 4 concerning the requirement to take all practicable steps to ensure that personal data are protected against unauthorized or accidental access, processing, erasure, loss or use.
