Notes on Completion of Notice of Withdrawal of Candidature

1. 獲提名而欲退出選舉的候選人,須填寫本通知書。此<u>通知書須由候選人於見證人在場下簽署</u>。任何年滿 18 歲並持有身分證明文件的人士,均可擔任見證人。根據《選舉管理委員會(選舉程序)(選舉委員會)規例》(第 541I 章)第 1(1) 條,"身分證明文件"指—

This notice must be completed by a nominated candidate who wishes to withdraw his/her candidature. This notice must be signed by the candidate in the presence of a witness who can be any person aged 18 years or over and in possession of an identity document. According to section 1(1) of the Electoral Affairs Commission (Electoral Procedure) (Election Committee) (Cap. 541I), "identity document" means –

- (a) 身分證;

- 3. 根據《行政長官選舉條例》(第569章)附表第21條,某項界別分組選舉中的候選人只可以在提名期結束前的任何時間退出,不再作為該選舉的候選人。填妥的通知書須於**提名期結束前(即2021年8月12日或之前)**由候選人或候選人的選舉代理人親自送遞有關的選舉主任。在該日期後,將不接受退選。選舉主任的地址已刊登在憲報內。

In accordance with section 21 of the Schedule to the Chief Executive Election Ordinance (Cap. 569), a candidate for a subsector election may withdraw the candidate's candidature at any time before the close of nominations. The duly completed notice must be delivered to the relevant Returning Officer by the candidate or the candidate's election agent in person **before the end of the nomination period (i.e. on or before 12 August 2021)**. **Withdrawal will not be accepted after that date.** The address of the Returning Officer has been specified in the Gazette.

A copy of this notice will be made available for public inspection in accordance with section 10 of the Electoral Affairs Commission (Electoral Procedure) (Election Committee) Regulation (Cap. 541I) until the Returning Officer or the Candidate Eligibility Review Committee makes a declaration for the relevant subsector under section 25 of Schedule to the Chief Executive Election Ordinance (Cap. 569), or the Returning Officer publishes a notice of the

result of the relevant subsector election under section 35 of Schedule to the Chief Executive Election Ordinance (Cap. 569). All identity document numbers and witness's address in this notice will be covered before display. The personal data and other related information supplied in connection with this notice may also be provided to other authorized departments or persons, including but not limited to the law courts for election-related purposes.

Access to Personal Data
