# 退回選舉按金說明

## Notes on Return of Election Deposit

1. 按金並不孳生利息。  
No interest will be accrued from the amount deposited.
2. 候選人擬要求退回按金，必須填妥第一部分，並將有關選舉按金收據的正本交回有關的選舉主任處理。如未能交回按金收據的正本，候選人須刪去表格第二段，並提供未能交回收據正本的原因。根據《立法會（提名所需的選舉按金及簽署人）規例》（第 542C 章）第 1(3)條，在此表格所提述的選舉主任，就某選區或選舉界別而言，亦包括該選區或選舉界別的助理選舉主任及總選舉事務主任。  
The candidate intending to request for a return of deposit must complete PART I and return the original receipt of the relevant election deposit to the relevant Returning Officer for action. If the original receipt cannot be returned, the candidate should strike out paragraph 2 and provide the reason why the original receipt cannot be returned.
