Notes on Completion of Standard Receipt for Election Donations

1. 當收取每項價值1,000元以上的選舉捐贈(不論是以金錢、貨品或服務形式抵付)時,候選人必須向 捐贈者發出收據,載明捐贈者的姓名或名稱及地址(一如捐贈者所提供的資料)及該項選舉捐贈的詳情。 捐贈者可選擇披露其屬意的地址,如其辦事處或業務地址、通訊地址、住址或郵政信箱號碼。

On receiving each election donation (whether by way of money, goods or service) of more than \$1,000 in value, candidate must issue to the donor a receipt which specifies the name and address of the donor (as supplied by the donor) and the particulars of such election donation. The donor may choose to disclose an address that he/she/it prefers, for example his/her/its office or business address, correspondence address, residential address or post office box number.

2. 選舉捐贈收據的正本應交予有關的捐贈者,其副本由候選人保存作記錄。

The original of the receipt for the election donation should be given to the donor concerned, and a copy of it should be kept by the candidate for record.

3. 候選人應另製備選舉捐贈收據的副本,以便連同「接受選舉捐贈預先申報書及聲明書」(表格編號: REO/C/16/2022LC(By-E)(SDF))(如適用)及「選舉開支及接受選舉捐贈之申報書及聲明書」(表格編號: REO/C/1/2022LC(By-E)(SF))一併向總選舉事務主任提交。

Candidate should make copies of receipts for election donations to be lodged with the Chief Electoral Officer together with "Advance Return and Declaration of Election Donations" (Form no.: REO/C/16/2022LC(By-E)(SDF)) (if applicable) and "Return and Declaration of Election Expenses and Election Donations" (Form no.: REO/C/1/2022LC(By-E)(SF)).

(b) <u>資料轉介</u>

Transfer of Information

A copy of this receipt for election donations and all attachments will be made available for public inspection. All personal data (except the name and address of the donor) in this receipt for election donations and all attachments will be covered before display. The personal data and other related information supplied in connection with this receipt for election donations may also be provided to other authorized departments or persons, including but not limited to the law courts for election-related purposes.

(c) <u>索閱個人資料</u>

Access to Personal Data

Any person has the right to request access to and correction of the personal data he/she supplied in this receipt for election donations in accordance with the provisions of the Personal Data (Privacy) Ordinance (Cap. 486).

(d) 個人資料保障原則

Personal Data Protection Principles

Candidates are reminded to observe the Data Protection Principles in Schedule 1 to the Personal Data (Privacy) Ordinance (Cap. 486) in collecting personal data of a third person in completing this receipt for election donations, in particular Principle 4 concerning the requirement to take all practicable steps to ensure that personal data are protected against unauthorized or accidental access, processing, erasure, loss or use.
