*I/Each of us, whose particulars are shown in paragraph 1 above, hereby accept(s) the appointment as stated in PART I of this notice.

 - (b) 試圖探取或透露有關任何選民/獲授權代表投票的任何資料; attempt to obtain or disclose any information concerning the vote of any elector/ authorized representative;
 - (c) 拍影片、拍照、錄音或錄影; film, take photographs or make any audio or video recording;

- 10. *我/我們每人亦明白,倘若*我/我們在投票站內或其鄰近範圍內或在禁止拉票區/禁止逗留區內行為不檢或行為不當,或不遵從有關的選舉主任或投票站主任的任何合法命令,即屬違法,可被判罰款及監禁,並可能會被有關的選舉主任或投票站主任命令立即離開該地方。倘若*我/我們沒有離開,可能會被警務人員或獲有關的選舉主任或投票站主任(視何者適用而定)以書面授權的人員逐離該地方。如*我/我們各人被逐離後,除非得到有關的選舉主任或投票站主任的許可,否則*我/我們在投票日不得再次進入有關地方。

*I/Each of us also understand(s) that if *I/we misconduct *myself/ourselves or behave in a disorderly manner at or in the vicinity of the polling station or within the no canvassing zone/no staying zone or fail to obey any lawful order of the relevant Returning Officer or the Presiding Officer, *I/we shall commit an offence punishable with a fine and imprisonment and may be ordered by the relevant Returning Officer or the Presiding Officer to leave the area immediately. *My/Our failure to leave such area may result in *my/our being removed by a police officer or a person authorized in writing by the relevant Returning Officer or the Presiding Officer, as may be appropriate. If *I/we are so removed, *I/we may not re-enter the relevant area on the polling day except with the permission of the relevant Returning Officer or the Presiding Officer.

Notes on Completion of Notice of Appointment of Polling Agents for a Polling Station Not Situated in a Penal Institution

 除非候選人以指明表格明文另作示明,有關代理人須當作是為在預定日期進行的投票和(如適用 的話)於遭押後的該次投票而委任。

The relevant agent is to be regarded as being appointed for the poll to be conducted on the scheduled date and (where applicable) the postponed or adjourned poll, unless the candidate(s) expressly indicate(s) otherwise in the specified form.

2. 候選人或其選舉代理人可在該候選人獲提名的選舉委員會界別選舉內,就每個非位於懲教院所內的投票站委任最多2名監察投票代理人。凡年滿18歲的香港身分證持有人均可被委任為監察投票代理人。候選人可委任同一人為多於一個投票站的監察投票代理人,但須在第一部分填寫有關的投票站名稱。如果某人被委任為所有供該選舉委員會界別選民投票的非位於懲教院所內的投票站的監察投票代理人,請在第一部分填寫「所有」。候選人或其選舉代理人不應委任總選舉主任、任何選舉主任、助理選舉主任、或任何已受總選舉事務主任委任協助進行投票或點票的人士為其監察投票代理人。

Candidate or his/her election agent may **appoint a maximum of 2 polling agents** for each polling station not situated in a penal institution in respect of the Election Committee constituency election for which the candidate is nominated. Any person who is a holder of a Hong Kong Identity Card and has attained the age of 18 years may be appointed as a polling agent. Candidate may appoint the same person as a polling agent for more than one polling station but the name of the relevant polling stations should be put in PART I. If a person is appointed as a polling agent for all the polling stations not situated in a penal institution for polling by electors of the Election Committee constituency concerned, please put "ALL" in PART I. A candidate or his/her election agent should not appoint the Chief Returning Officer, any Returning Officer, Assistant Returning Officer, or any person already appointed by the Chief Electoral Officer to assist at the poll or the count as his/her polling agent.

- 3. (a) 就每名候選人而言,在候選人、其選舉代理人或其監察投票代理人中,同一時間內只限 一人停留在一個投票站內監察投票。因此,如候選人或他/她的選舉代理人正停留在投票 站內,則該候選人的監察投票代理人不得同時停留在投票站內。
 - For each candidate, only **one** among the candidate, his/her election agent or his/her polling agent(s) may be present in a polling station to observe the poll at any one time. Therefore, when a candidate or his/her election agent is present in a polling station, a polling agent of that candidate shall not be present at the same time in the polling station.
 - (b) 投票站主任可以規限可進入投票站的候選人、選舉代理人或監察投票代理人的數目。如投票 站可容納該等人士的指定範圍已滿座,投票站主任可拒絕進一步讓該等人士在該等時間進入 投票站。
 - The admission into the polling station of a candidate, election agent or polling agent is subject to the overriding power of the Presiding Officer to regulate the number of persons admitted to the polling station. If full capacity of the area inside the polling station designated for such persons has been reached, the Presiding Officer may refuse further admission of such persons to the polling station at that point of time.
 - (c) 進入投票站的指定範圍監察投票一般採用先到先得的方法。假若在同一時間內要求進入指 定範圍的人數超額,將以抽籤決定進入的先後次序。
 - Admission to the designated area of the polling station to observe the poll will normally be on a first-come-first-served basis. If the number of persons seeking admission to the designated area at the same time exceeds the capacity, then lots will be drawn to determine the priority of entry.
 - (d) 獲准進入指定範圍的人士,只可在指定範圍內逗留<u>一小時</u>;除非其後在指定範圍內的人數並 未滿額,亦無其他人士在輪候進入該範圍,否則他/她必須離開。每位進入投票站指定範圍 的人士須在投票站職員保管的簽到冊簽到並記錄進入時間。
 - A person admitted to the designated area will only be allowed to stay in the designated area for <u>ONE HOUR</u>, thereafter he/she must leave unless the designated area is not fully occupied and no other person is waiting to be admitted to that designated area. Every person admitted to the designated area of the polling station is required to sign in and enter the time of admission on the log book kept by the polling staff.

(e) 當指定範圍所能容納的人數額滿時,輪候的每位人士會獲發一個號碼籌,以記錄指定範圍有空位時他/她獲准入內的次序。當輪到持有某一號碼籌的人士進入該範圍時,投票站工作人員會在投票站入口外讀出該號碼。如該號碼持有人當時並不在場,則持有下一個號碼籌的人士會被獲准進入指定範圍。當該缺席的人士再次回到投票站外時,便須重新領取另一號碼籌輪候。

When the designated area is full, each person waiting to be admitted will be issued a number chit in sequence to record the order of his/her entry to the designated area when a vacant seat arises. When it is the turn of the person holding the number chit to enter that area, his/her number will be called outside the entrance to the polling station, but if the holder of that number chit is not present at that time, then admission to the designated area will be granted to the one holding the next number chit. Such an absentee will have to obtain another number chit and join the queue afresh on his/her return to the polling station.

(f) 如候選人或其代理人要求進入投票站但直至投票結束前的所有等候時段已滿,即沒有空缺的時段可以分配給該候選人或其代理人。然而,如該候選人或其任何一位代理人均未曾於投票日進入該投票站觀察投票,相關的投票站主任會盡量透過特別安排給予該候選人/代理人於投票結束前進入該投票站觀察投票的機會。在這特別安排下,如果獲分配最後等候時段進入投票站的候選人或其任何一位代理人,已曾於較早時獲分配時段於該投票站觀察投票,上述要求進入投票站的候選人或其代理人將會取代此人,獲分配該時段。

If a candidate or his/her agent seeks admission to a polling station but all the waiting slots are full until the close of poll, no vacant slot can be allocated to the candidate or his/her agent. However, if none of this candidate or any of his/her agent has earlier entered the polling station to observe the poll on the polling day, the Presiding Officer concerned will endeavour to give the candidate/agent an opportunity to enter the polling station to observe the poll before the close of poll under a special arrangement. Under this special arrangement, the person will replace the candidate or his/her agent who has been allocated the last waiting slot for admission to the polling station if this last candidate or any of his/her agents has already been given an earlier slot to observe the poll at that polling station.

PART I of this notice should be completed and signed by the candidate or his/her election agent. PART II should be completed and signed by each of the polling agents.

5. 填妥的監察投票代理人的委任通知書,須於投票日前的第7天或之前(即2022年12月11日或 之前)藉專人送遞、郵遞、電子郵件或圖文傳真方式交付予總選舉事務主任,或於投票日,由候 選人或其選舉代理人親自向監察投票代理人所負責的投票站的投票站主任遞交。逾期遞交的通知 書將不予接納。監察投票代理人的委任,在總選舉事務主任或投票站主任(視何者適用而定)接 獲委任通知書後始生效。

The duly completed notice of appointment of polling agents must be delivered to the Chief Electoral Officer by hand, by post, by electronic mail or by facsimile transmission at least 7 days before the polling day (i.e. on or before 11 December 2022), or be delivered by the candidate or his/her election agent in person to the Presiding Officer of the polling station for which the polling agents are appointed on the polling day. Late submissions will not be accepted. The appointment of polling agents will not be effective until notice of appointment is received by the Chief Electoral Officer or the Presiding Officer, as may be appropriate.

Purpose of Collection

Access to Personal Data

(d) 個人資料保障原則
