## 填寫選舉廣告資料摘要說明

### Notes on Completion of Information Sheet in relation to Election Advertisements

1. 根據《選舉管理委員會（選舉程序）（區議會）規例》（第 541F 章）第 105 條，「發布」是指印刷、展示、展覽、分發、張貼、公布或以其他方式使公眾獲知，並包括繼續發布。  
According to section 105 of the Electoral Affairs Commission (Electoral Procedure) (District Councils) Regulation (Cap. 541F), “publish” means print, display, exhibit, distribute, post up, publicly announce or make publicly known by any other means, and includes continue to publish.
2. 「准許」是指私人土地的擁有人或佔用人或政府土地的主管當局根據《公眾衛生及市政條例》（第 132 章）第 104A(1)條，就候選人在該土地展示或張貼招貼或海報而給予的書面准許。  
“Permission” means the written permission of the owner or occupier of any private land or the authority of any government land given pursuant to section 104A(1) of the Public Health and Municipal Services Ordinance (Cap. 132) for a candidate to display or affix a bill or poster on such land.
3. 「同意書」是指任何人或組織根據《選舉（舞弊及非法行為）條例》（第 554 章）第 27 條，就候選人發布或授權發布收納了該人或組織的姓名、名稱或標識或跟該人或組織有關聯的姓名、名稱或標識；或與該人或組織的姓名、名稱或標識或與跟該人或組織有關聯的姓名、名稱或標識甚為相似的姓名、名稱或標識；或該人的圖像的選舉廣告，而給予的書面同意。  
“Consent” means the consent in writing given by any person or organization pursuant to section 27 of the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554) for a candidate to publish or authorize the publication of an election advertisement that includes the name or logo of or associated with the person or organization; or a name or logo that is substantially similar to the name or logo of or associated with the person or organization; or a pictorial representation of the person.
4. 在發布任何選舉廣告後的三（3）個工作天（即公眾假期及星期六以外的任何一天）內，如候選人打算以印本形式呈交其任何選舉廣告供公眾查閱，他／她必須向有關界別／選區的選舉主任提供每個有關選舉廣告的文本兩（2）份及相關的資料摘要一（1）份。至於實際上不能或不便以實物方式提交的選舉廣告，候選人則須就每個選舉廣告提供一式兩（2）份全彩色相片／打印本／影印本及一（1）份相關的資料摘要。候選人必須確保提供的選舉廣告詳情符合《選舉管理委員會（選舉程序）（區議會）規例》（第 541F 章）第 106 條及《區議會選舉活動指引》第七章的規定及要求。候選人必須藉專人送遞或郵遞向有關界別／選區的選舉主任交付資料摘要正本。  
If a candidate wishes to submit any election advertisement(s) in a hard copy format for public inspection, he/she must provide to the Returning Officer for the relevant constituency two (2) copies for each of the election advertisement concerned together with one (1) copy of the relevant Information Sheet in related to the Election Advertisement (“Information Sheet”) **within three (3) working days (i.e. any day other than a general holiday and Saturday) after publication** of any election advertisement(s). In respect of the election advertisement(s) which cannot be practically or conveniently produced in specie, two (2) identical full-colour photographs/printouts/photocopies of each election advertisement together with one (1) copy of the relevant Information Sheet must be provided. The candidate must ensure that the election advertisement particulars provided comply with the rules and requirements as set out in section 106 of the Electoral Affairs Commission (Electoral Procedure) (District Councils) Regulation (Cap. 541F), and Chapter 7 of the “Guidelines on Election-related Activities in respect of the District Council Election”. The candidate must deliver the original copy of the Information Sheet to the Returning Officer for the relevant constituency by hand or by post.
5. 如已提交予有關界別／選區的選舉主任的資料摘要需要作出修正，候選人必須向有關界別／選區的選舉主任提交「修正選舉廣告資料摘要通知書」（表格編號：REO/C/11/DC(SF)(2023)）（“修正通知書”），任何修正的資料須在不遲於選舉日後的三（3）個工作天內或在押後的選舉日後的三（3）個工作天內（如適用）提交予有關界別／選區的選舉主任。如候選人沒有提交任何修正通知書，則相關的資料摘要將被視為其中一個依據，用以審查和核對候選人的「選舉開支及接受選舉捐贈之申報書及聲明書」。  
If subsequent correction to the Information Sheet submitted to the Returning Officer for the relevant constituency is required, the candidate must submit to the Returning Officer for the relevant constituency a “**Notification of Corrected Information in relation to Election Advertisements**” (Form no.: REO/C/11/DC(SF)(2023)) (“Notification of Correction”). Any such corrected information must be submitted to the Returning Officer for the relevant constituency **not later than three (3) working days after the polling day or not later than three (3) working days after the postponed or adjourned polling day (where applicable)**. If no **Notification of Correction** has been so submitted, the relevant Information Sheet will be used as one of the basis for examining and checking the candidate’s “Return and Declaration of Election Expenses and Election Donations”.
6. 如尚未就某界別／選區委任選舉主任，在此資料摘要中所提述選舉主任之處，均須解釋為提述總選舉事務主任。  
If the Returning Officer has not yet been appointed for a constituency, the references in this Information Sheet to a Returning Officer are to be construed as references to the Chief Electoral Officer.

(a) **資料用途**

就此資料摘要提供的個人及其他有關的資料，會供選舉管理委員會、選舉事務處、有關界別／選區的選舉主任及其他有關的政府部門用於與選舉有關的用途。

**Purpose of Collection**

The personal data and other relevant information provided in this Information Sheet will be used by the Electoral Affairs Commission, the Registration and Electoral Office, the Returning Officer for the relevant constituency and other relevant government departments for election-related purposes.

(b) **資料轉介**

有關界別／選區的選舉主任在收到資料摘要、准許或授權書、同意書或選舉廣告樣本後，會將副本供公眾查閱直至選舉申報書的文本根據《選舉（舞弊及非法行為）條例》（第 554 章）第 41 條可供查閱的期間結束為止。在展示前，文件內所有身分證明文件號碼將會被遮蓋。就此資料摘要提供的個人及其他有關的資料亦可能會提供予其他獲授權的部門或人士，包括但不限於法院，用於與選舉有關的用途。

**Transfer of Information**

A copy of the Information Sheet, permission or authorization, consent or election advertisement samples will be made available by the Returning Officer for the relevant constituency who has received them for public inspection until the end of the period for which copies of election returns are available for inspection pursuant to section 41 of the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554). All identity document numbers in the documents will be covered before display. The personal data and other relevant information provided in connection with this Information Sheet may also be provided to other authorized departments or persons, including but not limited to the law courts for election-related purposes.

(c) **索閱個人資料**

任何人有權根據《個人資料（私隱）條例》（第 486 章）的條文要求索閱及改正他／她在此資料摘要所提供的個人資料。

**Access to Personal Data**

Any person has the rights to request access to and correction of the personal data he/she provided in this Information Sheet in accordance with the provisions of the Personal Data (Privacy) Ordinance (Cap. 486).

(d) **個人資料保障原則**
