and Notes on Eligibility and Disqualification of Candidates**

1. 準候選人只可使用本指明的申請表（REO/NAC/1/2025LC(SF)），就他／她是否在立法會換屆選舉有資格獲提名為候選人或是否喪失該資格，向提名顧問委員會（“顧問委員會”）要求提供意見。  
A prospective candidate may apply, only by using this specified application form (REO/NAC/1/2025LC (SF)), for the advice of a Nominations Advisory Committee (“the Committee”) as to whether he/she is eligible to be, or is disqualified from being, nominated as a candidate at a general election of the Legislative Council.
2. 準候選人只可以－

The Committee may also before giving its advice request the applicant to present himself/herself before the Committee at a specified time and place to assist the Committee in the consideration of his/her application. The applicant may at the specified time and place make representations relating to his/her intended candidature to the Committee personally or through any person authorized by him/her in writing.

Eligibility for nomination as a candidate, disqualification from being nominated as a candidate or from being elected as a Member, and requirements are to be complied with by persons nominated as candidates in respect of the geographical constituency, functional constituency and Election Committee constituency elections are stipulated in sections 37, 39 and 40 of the Legislative Council Ordinance (Cap. 542) which are reproduced below for reference -

- (1) 符合以下條件的人方有資格在地方選區的選舉中獲提名為候選人－
  - (a) 年滿 21 歲；及
  - (b) 已登記為地方選區的選民並有資格如此登記；及
  - (c) 並未有憑藉第 39 條或任何其他法律喪失獲選為議員的資格；及
  - (d) 在緊接提名前的 3 年內通常在香港居住；及
  - (e) 是香港永久性居民中的中國公民，並且沒有中華人民共和國以外的國家的居留權。
- (2) 符合以下條件的人方有資格在某功能界別的選舉中獲提名為候選人－
  - (a) 年滿 21 歲；及
  - (b) (i) 已登記為並有資格登記為該功能界別的選民；或
  - (ii) 令該功能界別的選舉主任信納他與該功能界別有密切聯繫；及
  - (c) 已登記為地方選區的選民並有資格如此登記；及

- (d) 並未有憑藉第 39 條或任何其他法律喪失獲選為議員的資格；及
  - (e) 在緊接提名前的 3 年內通常在香港居住；及
  - (f) 是香港永久性居民中的中國公民，並且沒有在中華人民共和國以外的國家的居留權，但第 (3) 款指明的 12 個功能界別除外。

- (a) 年滿 21 歲；及
  - (b) 已登記為地方選區的選民並有資格如此登記；及
  - (c) 並未有憑藉第 39 條或任何其他法律喪失獲選為議員的資格；及
  - (d) 在緊接提名前的 3 年內通常在香港居住；及
  - (e) 是香港永久性居民中的中國公民，並且沒有中華人民共和國以外的國家的居留權。
- (4) 議員並無資格在補選中獲提名為候選人。

*Section 37 Who is eligible to be nominated as a candidate*

- (1) A person is eligible to be nominated as a candidate at an election for a geographical constituency only if the person -
  - (a) has reached 21 years of age; and
  - (b) is both registered and eligible to be registered as an elector for a geographical constituency; and
  - (c) is not disqualified from being elected as a Member by virtue of section 39 or any other law; and
  - (d) has ordinarily resided in Hong Kong for the 3 years immediately preceding the nomination; and
  - (e) is a Chinese citizen who is a permanent resident of Hong Kong with no right of abode in any country other than the People's Republic of China.
- (2) A person is eligible to be nominated as a candidate at an election for a functional constituency only if the person -
  - (a) has reached 21 years of age; and
  - (b) either -
    - (i) is both registered and eligible to be registered as an elector for the constituency; or
    - (ii) satisfies the Returning Officer for the constituency that the person has a substantial connection with the constituency; and
  - (c) is both registered and eligible to be registered as an elector for a geographical constituency; and
  - (d) is not disqualified from being elected as a Member by virtue of section 39 or any other law; and
  - (e) has ordinarily resided in Hong Kong for the 3 years immediately preceding the nomination; and
  - (f) except in the case of the 12 functional constituencies specified in subsection (3), is a Chinese citizen who is a permanent resident of Hong Kong with no right of abode in any country other than the People's Republic of China.
- (3) The following 12 functional constituencies are specified for the purposes of subsection (2) -
  - (a) the legal functional constituency;
  - (b) the accountancy functional constituency;
  - (c) the engineering functional constituency;
  - (d) the architectural, surveying, planning and landscape functional constituency;
  - (e) the real estate and construction functional constituency;

- (f) the tourism functional constituency;
  - (g) the commercial (first) functional constituency;
  - (h) the industrial (first) functional constituency;
  - (i) the finance functional constituency;
  - (j) the financial services functional constituency;
  - (k) the import and export functional constituency;
  - (l) the insurance functional constituency.
- (3A) A person is eligible to be nominated as a candidate at an election for the Election Committee constituency only if the person -
- (a) has reached 21 years of age; and
  - (b) is both registered and eligible to be registered as an elector for a geographical constituency; and
  - (c) is not disqualified from being elected as a Member by virtue of section 39 or any other law; and
  - (d) has ordinarily resided in Hong Kong for the 3 years immediately preceding the nomination; and
  - (e) is a Chinese citizen who is a permanent resident of Hong Kong with no right of abode in any country other than the People's Republic of China.
- (4) A Member is not eligible to be nominated as a candidate at a by-election.

    - (ii) 在違反《選舉（舞弊及非法行為）條例》（第554章）的情況下作出舞弊或非法行為；或
    - (iii) 《防止賄賂條例》（第201章）第II部所訂的罪行；或
    - (iv) 《區議會條例》（第547章）附表4A第7條所訂明或根據《選舉管理委員會條例》（第541章）訂立並正有效的規例所訂明的任何罪行；或
  - (f) 因本條例或任何其他法律的施行而－
    - (i) 無資格在選舉中成為候選人或當選為議員；或
    - (ii) 喪失在選舉中成為候選人或當選為議員的資格；或
  - (g) 是香港以外地方的政府的代表或該政府的受薪政府人員；或
  - (h) 是香港以外任何地方的國家級、地區級或市級立法機關、議院或議會（中華人民共和國的全國或地方人民代表大會或人民協商機構除外）的成員；或
  - (i) 是未獲解除破產的人，或於過去5年內在沒有向債權人全數償還債務的情況下，獲解除破產或與其債權人訂立《破產條例》（第6章）所指的自願安排的人。
- (1A) 任何人如有以下情況，亦即喪失在選舉中獲提名為候選人的資格及當選為議員的資格－
- (a) 該人因拒絕或忽略作出指明誓言而根據法律離任，或喪失就任的資格，而選舉於或將於該

- 人離任或喪失資格的日期後的 5 年內舉行；或
- (b) 該人被按照任何法律宣告、宣布或裁定為—
- (i) 違反指明誓言；或
  - (ii) 不符合擁護《基本法》、效忠中華人民共和國香港特別行政區的法定要求和條件，而選舉於或將於作出該項宣告、宣布或裁定的日期後的 5 年內舉行。
- (2) 任何人如根據《精神健康條例》（第 136 章）已被裁斷為因精神上無行為能力而無能力處理和管理其財產及事務，即喪失在選舉中獲提名為候選人的資格，但如在其後根據該條例被裁斷為已有能力處理和管理其財產及事務，則根據本款喪失資格的人有獲提名為候選人的資格。
- (2A) 如有以下情況，某人亦喪失在任何補選中獲提名為候選人的資格—
- (a) 該人—
    - (i) 根據第 14 條辭去議員席位，而其辭職在截至該補選當日為止的 6 個月期間內生效；或
    - (ii) 在截至該補選當日為止的 6 個月期間內，根據第 13(3)條被視為已辭去議員席位；及
  - (b) 在有關辭職通知或不接受席位的通知生效後，並無換屆選舉舉行。
- (3) 任何人如根據《精神健康條例》（第 136 章）已被裁斷為因精神上無行為能力而無能力處理和管理其財產及事務，即喪失當選為議員的資格，但如在其後根據該條例被裁斷為已有能力處理和管理其財產及事務，則根據本款喪失資格的人有當選為議員的資格。
- (4) 任何人如在提名期結束後已不再與某功能界別有密切聯繫，則該人即喪失當選為該功能界別的議員的資格。
- (5) 在本條中—

**司法人員** (judicial officer) 指擔任《公務員敍用委員會條例》（第 93 章）第 2 條所界定的司法職位的人；

**指明誓言** (specified oath) 指根據法律作出的以下誓言：宣誓者會擁護《基本法》、效忠中華人民共和國香港特別行政區。

**訂明的公職人員** (prescribed public officer) 指—

- (a) 公務員敍用委員會主席；
- (b) 廉政專員、副廉政專員及擔任在《廉政公署條例》（第 204 章）下的任何其他職位的人；
- (c) 申訴專員及根據《申訴專員條例》（第 397 章）第 6 條獲委任的人；
- (d) 選舉管理委員會的成員；
- (e) 金融管理局的行政總裁及該局的高層管理人員，包括科主管、行政總監、經理及該局僱用的律師；或
- (ea) 個人資料私隱專員及其根據《個人資料（私隱）條例》（第 486 章）僱用或聘用的人；
- (eb) 平等機會委員會的主席及由該委員會根據《性別歧視條例》（第 480 章）僱用或聘用的人；
- (f) 受僱於政府部門或政策局而在該政府部門或政策局任職（不論該職位屬永久性或臨時性的）的人。

### *Section 39 When person is disqualified from being nominated as a candidate and from being elected as a Member*

- (1) A person is disqualified from being nominated as a candidate at an election, and from being elected as a Member, if the person -
- (a) is -
    - (i) a judicial officer; or
    - (ii) a prescribed public officer; or
    - (iii) an officer of the Legislative Council or a member of staff of The Legislative Council Commission; or
  - (b) has, in Hong Kong or any other place, been sentenced to death or imprisonment (by whatever name called) and has not either -
    - (i) served the sentence or undergone such other punishment as a competent authority may have been substituted for the sentence; or

- (ii) received a free pardon; <sup>1</sup>or
  - (c) has been convicted of an offence endangering national security; or
  - (d) on the date of nomination, or of the election, is serving a sentence of imprisonment; or
  - (e) without limiting paragraph (b), where the election is to be held or is held within 5 years after the date of the person's conviction, is or has been convicted -
    - (i) in Hong Kong or any other place, of an offence for which the person has been sentenced to imprisonment, whether suspended or not, for a term exceeding 3 months without the option of a fine; or
    - (ii) of having engaged in corrupt or illegal conduct in contravention of the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554); or
    - (iii) of an offence against Part II of the Prevention of Bribery Ordinance (Cap. 201); or
    - (iv) of any offence prescribed by section 7 of Schedule 4A to the District Councils Ordinance (Cap. 547) or regulations in force under the Electoral Affairs Commission Ordinance (Cap. 541); or
  - (f) is -
    - (i) ineligible to be a candidate, or to be elected as a Member, at the election; or
    - (ii) disqualified from being a candidate, or from being elected as a Member, at the election, because of the operation of this or any other law; or
  - (g) is a representative or salaried functionary of a government of a place outside Hong Kong; or
  - (h) is a member of any national, regional or municipal legislature, assembly or council of any place outside Hong Kong, other than a people's congress or people's consultative body of the People's Republic of China, whether established at the national or local level; or
  - (i) is an undischarged bankrupt or, within the previous 5 years, has either obtained a discharge in bankruptcy or has entered into a voluntary arrangement within the meaning of the Bankruptcy Ordinance (Cap. 6) with the person's creditors, in either case without paying the creditors in full.
- (1A) A person is also disqualified from being nominated as a candidate at an election, and from being elected as a Member, if the election is held or is to be held within 5 years after -
- (a) the date on which the person vacates an office, or is disqualified from entering on an office, under the law, for declining or neglecting to take a specified oath; or
  - (b) the date on which the person is declared or decided in accordance with any law -
    - (i) to be in breach of a specified oath; or
    - (ii) to have failed to fulfil the legal requirements and conditions on upholding the Basic Law and bearing allegiance to the Hong Kong Special Administrative Region of the People's Republic of China.
- (2) A person is also disqualified from being nominated as a candidate at an election if the person has been found under the Mental Health Ordinance (Cap. 136) to be incapable, by reason of mental incapacity, of managing and administering his or her property and affairs, but a person disqualified under this subsection is eligible for nomination as a candidate if, under that Ordinance, it is subsequently found that the person has become capable of managing and administering his or her property and affairs.
- (2A) A person is also disqualified from being nominated as a candidate at a by-election if -
- (a) within the 6 months ending on the date of the by-election -
    - (i) the person's resignation under section 14 as a Member took effect; or
    - (ii) the person was taken under section 13(3) to have resigned from office as a Member; and
  - (b) no general election was held after the relevant notice of resignation or notice of non-acceptance took effect.
- (3) A person is also disqualified from being elected as a Member if the person has been found under the Mental Health Ordinance (Cap. 136) to be incapable, by reason of mental incapacity, of managing and administering his or her property and affairs, but a person disqualified under this subsection ceases to be disqualified if, under that Ordinance, it is subsequently found that the person has become capable of managing and administering his or her property and affairs.
- (4) A person is also disqualified from being elected as a Member for a functional constituency if, since the

close of nominations, the person has ceased to have a substantial connection with the constituency.

(5) In this section-

**judicial officer** (司法人員) means the holder of a judicial office, as defined in section 2 of the Public Service Commission Ordinance (Cap. 93);

**prescribed public officer** (訂明的公職人員) means any of the following -

- (a) the Chairman of the Public Service Commission;
- (b) the Commissioner and Deputy Commissioner of the Independent Commission Against Corruption and the holder of any other office under the Independent Commission Against Corruption Ordinance (Cap. 204);
- (c) The Ombudsman and the holder of any appointment under section 6 of The Ombudsman Ordinance (Cap. 397);
- (d) a member of the Electoral Affairs Commission;
- (e) the chief executive of the Monetary Authority and any member of the senior management of that Authority, including divisional heads, executive directors, managers and counsel employed by that Authority;
- (ea) the Privacy Commissioner for Personal Data and any person employed or engaged by him or her under the Personal Data (Privacy) Ordinance (Cap. 486);
- (eb) the Chairperson of the Equal Opportunities Commission and any person employed or whose services are engaged by the Commission under the Sex Discrimination Ordinance (Cap. 480);
- (f) any person holding an office, whether permanent or temporary, in a Government department or bureau and employed in the department or bureau;

**specified oath** (指明誓言) means an oath taken under the law that the oath-taker will uphold the Basic Law and bear allegiance to the Hong Kong Special Administrative Region of the People's Republic of China.

      - (I) 在違反《選舉（舞弊及非法行為）條例》（第 554 章）的情況下作出舞弊或非法行為；或
      - (II) 《防止賄賂條例》（第 201 章）第 II 部所訂的罪行；或
      - (III) 《區議會條例》（第 547 章）附表 4A 第 7 條所訂明或根據《選舉管理委員會條例》（第 541 章）訂立並正有效的規例所訂明的任何罪行；
    - (E) 由於本法例或任何其他法例的實施而喪失在選舉中獲選為議員的資格；
    - (F) 成為香港以外地方的政府的代表或該政府的受薪政府人員；
    - (G) 成為香港以外任何地方的國家級、地區級或市級立法機關、議院或議會（中華人民共和國的全國或地方人民代表大會或人民協商機構除外）的成員；
    - (H) 成為中央人民政府或任何其他國家或地區的武裝部隊的成員；或
    - (I) （如是某功能界別選出的議員）不再與有關功能界別有密切聯繫。

(2) 該人必須簽署該等聲明。

(3) 按金須為《規例》為施行本條而訂明的款額。

*Section 40 What requirements are to be complied with by persons nominated as candidates*

- (1) A person is not validly nominated as a candidate for an election for a constituency unless -
  - (a) a deposit has, in the manner prescribed by regulations in force under the Electoral Affairs Commission Ordinance (Cap. 541), been lodged by or on behalf of the person with the Returning Officer concerned; and
  - (b) the nomination form includes or is accompanied by -
    - (i) a declaration to the effect that the person will uphold the Basic Law and pledge allegiance to the Hong Kong Special Administrative Region; and
    - (ii) a declaration as to the person's nationality and as to whether or not the person has a right of abode in a country other than the People's Republic of China; and
    - (iii) a promissory oath given by the person to the effect that, if elected, he or she will not do anything during his or her term of office that results in his or her -
      - (A) becoming -
        - (I) a prescribed public officer within the meaning of section 39(5); or
        - (II) an officer of the Legislative Council or a member of staff of The Legislative Council Commission;
      - (B) being sentenced to death in Hong Kong or any other place;
      - (C) being convicted of an offence endangering national security;
      - (D) being convicted -
        - (I) of having engaged in corrupt or illegal conduct in contravention of the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554); or
        - (II) of an offence against Part II of the Prevention of Bribery Ordinance (Cap. 201); or
        - (III) of any offence prescribed by section 7 of Schedule 4A to the District Councils Ordinance (Cap. 547) or regulations in force under the Electoral Affairs Commission Ordinance (Cap. 541);
      - (E) being disqualified from being elected as a Member at an election because of the operation of this or any other law;
      - (F) becoming a representative or salaried functionary of a government of a place outside Hong Kong;
      - (G) becoming a member of any national, regional or municipal legislature, assembly or council of any place outside Hong Kong, other than a people's congress or people's consultative body of the People's Republic of China, whether established at the national or local level;
      - (H) becoming a member of the armed forces of the Central People's Government or any other country or territory; or
      - (I) in the case of a Member elected for a functional constituency, ceasing to have a substantial connection with the constituency.
  - (2) The person must sign the declarations.
  - (3) The deposit is to be of such an amount as is prescribed by the regulations for the purposes of this section.
