注意: 聯合選舉郵件內載有的選舉廣告很大可能意味着或導致選民相信發布選舉廣告的候選人獲得選舉廣告所提述的其他候選人的支持。為符合《選舉(舞弊及非法行為)條例》(第554章)第27條的規定,候選人必須事先向其他候選人取得書面支持同意書。就此,候選人須在投寄免費聯合選舉郵件之前向有關選舉主任繳存有關支持同意書文本或將其上載至中央平台或候選人平台。

Remarks: The election advertisement contained in a joint election mail would very likely imply or cause electors to believe that the candidate publishing the election advertisement has the support of another candidate mentioned in the election advertisement. In order to comply with section 27 of the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554), **prior written consent of support must be obtained from another candidate**. In this regard, candidate must deposit a copy of the relevant "consent of support" with the relevant Returning Officer or upload it to the Central Platform or Candidate's Platform **before** posting a joint election mail free of postage.

#### 我現謹作以下聲明並明白:

I hereby declare and understand that:

- (a) 選舉郵件只載有與本通知書所提述的候選人參選上述選舉相關的物料;
  - the election mail contains materials relating only to the candidature of the candidate(s) mentioned in this notice at the above election;
- (b) 每封選舉郵件重量不超過 50 克;
  - each election mail does not exceed 50 grams in weight;
- (c) 每封選舉郵件尺寸不大於 165 毫米乘以 245 毫米,亦不小於 90 毫米乘以 140 毫米;
- each election mail is not larger than 165 mm x 245 mm and not smaller than 90 mm x 140 mm in size;
- (d) 每封選舉郵件任何部分的厚度不超過5毫米;
  - each election mail does not exceed 5 mm in thickness at any part of the letter;
- (e) 選舉郵件不含有任何淫褻、不道德、不雅、令人反感、帶永久形式誹謗或會構成危害國家安全的罪行的文字、圖片或其他東 西;
  - the election mail does not contain any obscene, immoral, indecent, offensive or libelous writing, picture or other thing, or anything which would constitute an offence endangering national security;
- (f) 如果選舉郵件中收納了某人士或組織的姓名、名稱、標識或圖像(視屬何情況而定),而發布的方式意味着或相當可能導致 選民相信本通知書所提述的候選人已獲得該人或該組織的支持,候選人均已事先取得該人或該組織的書面同意;
  - if the name, logo or pictorial representation of a person or an organization (as the case may be) is included in the election mail, and the publication is in such a way as to imply or to be likely to cause electors to believe that the candidate(s) mentioned in this notice has/have the support of that person or organization, the candidate(s) has/have obtained prior written consent from that person or organization;

  - the Electoral Affairs Commission and the Government of the Hong Kong Special Administrative Region (including Hongkong Post and the Registration and Electoral Office) shall not be responsible to the candidate(s) and any third party for the election mail, including but not limited to any liabilities arising from any errors in, omissions from, false or misleading statements in the contents of the election mail. The candidate(s) posting the election mail shall be responsible for the election mail and its contents, and shall indemnify and keep indemnified the Electoral Affairs Commission and the Government against all liabilities, costs, expenses, legal actions, legal proceedings, claims, demands, losses and damages arising out of or in connection with the election mail and its contents; and

1. 2025 年立法會換屆選舉免付郵資寄出選舉郵件的截郵日期為 2025 年 11 月 22 日,在該日期後投寄的選舉郵件將很可能無法在投票日前寄達選民。為確保香港郵政可於上述截郵日期前處理所有選舉郵件樣本,候選人/選舉代理人最遲須於 2025 年 11 月 19 日提交最終樣本予香港郵政。

The posting deadline for postage-free election mail for 2025 Legislative Council General Election is on 22 November 2025. Please note that election mail posted after the posting deadline will unlikely reach the electors before the polling day. In order to ensure that Hongkong Post could process all specimens of election mail before the posting deadline, candidates/election agents should submit the final specimens to Hongkong Post by 19 November 2025 the latest.

### (a) 資料用途

就此通知書提供的個人資料及其他有關的資料,會供香港郵政、選舉事務處、有關選舉主任、選舉管理委員會及其他有關的政府部門和機構用於與選舉有關的用途。

## Purpose of Collection

The personal data and other related information provided in connection with this notice will be used by Hongkong Post, the Registration and Electoral Office, the relevant Returning Officer, the Electoral Affairs Commission and other related government departments and organizations for election-related purposes.

## (b) <u>資料轉介</u>

就此通知書提供的所有資料(包括個人資料及其他資料)可能會提供予其他獲授權的部門、機構或人士,包括但不限於法院,用於與選舉有關的用途。

### **Transfer of Information**

All information (including the personal data and other information) provided in this notice may be provided to other authorized departments, organizations or persons, including but not limited to the law courts for election-related purposes.

#### (c) 索閱個人資料

任何人有權根據《個人資料(私隱)條例》(第 486 章)的條文要求索閱及改正他/她在此通知書所提供的個人資料。

#### Access to Personal Data

Any person has the rights to request access to and correction of the personal data he/she provided in this notice in accordance with the provisions of the Personal Data (Privacy) Ordinance (Cap. 486).

## (d) 個人資料保障原則

候選人應留意,在收集第三者的個人資料以填寫此通知書時,須遵守《個人資料(私隱)條例》(第486章)附表 1的保障資料原則,特別是第4原則,即採取所有切實可行的步驟,以確保個人資料受保障而不受未獲准許的或 意外的查閱、處理、刪除、喪失或使用所影響。

### Personal Data Protection Principles

Candidates are reminded to observe the Data Protection Principles in Schedule 1 to the Personal Data (Privacy) Ordinance (Cap. 486) in collecting personal data of a third person in completing this notice, in particular Principle 4 concerning the requirement to take all practicable steps to ensure that any personal data is protected against unauthorized or accidental access, processing, erasure, loss or use.
