Notes on Completion of Notification of Decision on Electioneering Activities

1. 請公平及平等對待所有候選人，以確保選舉公平進行。
To ensure that the election is conducted fairly, please provide fair and equal treatment to all candidates.
2. 根據《選舉管理委員會（選舉程序）（立法會）規例》（第 541D 章）第 104 條，「發布」是指印刷、展示、展覽、分發、張貼、公布或以其他方式使公眾獲知，並包括繼續發布。
According to section 104 of the Electoral Affairs Commission (Electoral Procedure) (Legislative Council) Regulation (Cap. 541D), “publish” means print, display, exhibit, distribute, post up, publicly announce or make publicly known by any other means, and includes continue to publish.

5. 根據《立法會選舉活動指引》第九章及《選舉管理委員會（選舉程序）（立法會）規例》（第 541D 章）第 105 條，候選人須在發布選舉廣告後的 **3 個工作天（即公眾假期及星期六以外的任何 1 天）內**，把與選舉廣告有關的資料／文件，包括准許或同意書的電子文件，上載至中央平台或候選人平台或向選舉主任提交其印本式文本，以供公眾查閱。
In accordance with Chapter 9 of the “Guidelines on Election-related Activities in respect of the Legislative Council Election” and section 105 of the Electoral Affairs Commission (Electoral Procedure) (Legislative Council) Regulation (Cap. 541D), the candidate must, **within 3 working days (i.e. any day other than a general holiday and Saturday)** after publication of an election advertisement, upload an electronic copy of the relevant information/document of the election advertisement, including permission or consent, onto the Central Platform or Candidate’s Platform, or submit a hard copy to the Returning Officer for public inspection.

Please note the following with regard to the provision of personal data in connection with this notification –

(a) **資料用途**

就此通知書提供的個人及其他有關的資料，會供選舉管理委員會、選舉事務處、有關選舉主任及其他有關的政府部門和機構用於與選舉有關的用途。

Purpose of Collection

The personal data and other relevant information provided in this notification will be used by the Electoral Affairs Commission, the Registration and Electoral Office, the relevant Returning Officer and other relevant government departments and organizations for election-related purposes.

(b) **資料轉介**

此通知書會供公眾查閱直至選舉申報書的文本根據《選舉（舞弊及非法行為）條例》（第 554 章）第 41 條可供查閱的期間結束為止。在展示前，通知書內所有電話號碼將會被遮蓋。就此通知書提供的個人及其他有關的資料亦可能會提供予其他獲授權的部門、機構或人士，包括但不限於法院，用於與選舉有關的用途。

Transfer of Information

This notification will be made available for public inspection until the end of the period for which copies of election returns are available for inspection pursuant to section 41 of the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554). All telephone numbers in the notification will be covered before display. The personal data and other relevant information provided in connection with this notification may also be provided to other authorized departments, organizations or persons, including but not limited to the law courts for election-related purposes.

(c) **索閱個人資料**

任何人有權根據《個人資料（私隱）條例》（第 486 章）的條文要求索閱及改正他／她所提供的個人資料。

Access to Personal Data

Any person has the rights to request access to and correction of the personal data he/she provided in accordance with the provisions of the Personal Data (Privacy) Ordinance (Cap. 486).

(d) **個人資料保障原則**

候選人及代理人應留意，在收集第三者的個人資料以填寫此通知書時，須遵守《個人資料（私隱）條例》（第 486 章）附表 1 的保障資料原則，特別是第 4 原則，即採取所有切實可行的步驟，以確保個人資料受到保障而不受未獲准許的或意外的查閱、處理、刪除、喪失或使用。

Personal Data Protection Principles

Candidates and agents are reminded to observe the Data Protection Principles in Schedule 1 to the Personal Data (Privacy) Ordinance (Cap. 486) in collecting personal data of a third party in completing this notification, in particular Principle 4 concerning the requirement to take all practicable steps to ensure that personal data are protected against unauthorized or accidental access, processing, erasure, loss or use.
