Return and Declaration of Election Expenses and Election Donations

此指南說明如何填寫選舉開支及接受選舉捐贈之申報書及聲明書並夾附已填妥的樣本,以供候選人參考。有關選舉開支及選舉捐贈的法例,請參閱《選舉(舞弊及非法行為)條例》(第 554 章)及《選舉管理委員會(選舉程序)(選舉委員會)規例》(第 5411 章)。

This Guide explains how to complete the Return and Declaration of Election Expenses and Election Donations and includes a sample of a completed return and declaration for candidates' reference. For legislation concerning election expenses and election donations, please refer to the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554) and the Electoral Affairs Commission (Electoral Procedure) (Election Committee) Regulation (Cap. 541I).

填寫選舉開支及接受選舉捐贈之申報書及聲明書說明

Notes on Completion of Return and Declaration of Election Expenses and Election Donations

1. 填寫選舉開支及接受選舉捐贈申報書及聲明書前,請閱讀選舉管理委員會發出的《選舉委員會界別分組選舉活動指引》第十六章,以及參考廉政公署編製的「廉潔選舉資料冊」中有關選舉開支及選舉捐贈的資料和此指南夾附的「已填妥的申報書及聲明書(樣本)」。

Before completing the Return and Declaration of Election Expenses and Election Donations, please read Chapter 16 of the "Guidelines on Election-related Activities in respect of the Election Committee Subsector Elections" issued by the Electoral Affairs Commission. Please also make reference to the "Clean Election Information Booklet" produced by the Independent Commission Against Corruption for the parts concerning election expenses and election donations, and the "Sample of a completed return and declaration" included in this Guide.

2. 根據《選舉(舞弊及非法行為)條例》(第554章)第37(1)條的規定,此申報書及聲明書中必須列出候選人在選舉中的選舉開支及曾由候選人或由他人代該候選人在與選舉有關連的情況下收取的所有選舉捐贈。

According to section 37(1) of the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554), this return and declaration must set out the candidate's election expenses at the election and all election donations received by or on behalf of the candidate in connection with the election.

3. 請用中文或英文填寫此申報書及聲明書。如任何部分篇幅不敷應用,可採用同樣格式另紙填寫,然後作為附件夾附 於此申報書及聲明書。

Please complete this return and declaration either in Chinese or in English. Please use additional sheet(s) in the same format to set out the particulars and then attach the same as appendix/appendices to this return and declaration if the space provided in any Section is insufficient.

4. 此申報書及聲明書內的金額及價值須以港元表示。填寫金額或價值時,如在分攤開支或轉換幣值的情況下經計算的金額有小數位,請將金額或價值以整數或四捨五入至不超過兩個小數位填寫。

All amounts and values in this return and declaration must be expressed in Hong Kong dollars. When filling in the amount or value, if the amount has decimal places after calculation due to apportionment of the expenses or conversion of currency, please fill in the amount or value with an integer or round up/down to not more than 2 decimal places.

- 5. 就每項 500 元或以上的選舉開支而言,候選人必須提交載有該項支出詳情的發票及收據。選舉開支的發票及收據可分為不同文件提交,亦可包含於同一份文件內。候選人提交的發票及收據必須載有以下資料-
 - (a) 日期
 - (b) 開支項目的詳情(即貨品或服務的資料和金額);
 - (c) 提供貨品或服務的機構或人士(非候選人本人)的資料;及
 - (d) 證明提供貨品或服務的機構或人士(非候選人本人)已全數收取有關款額的資料(例如收款人士的姓名及簽署,或收款機構的蓋章或其授權代表的簽署)。

In the case of each election expense of \$500 or more, candidate must submit an invoice and a receipt giving particulars of such expenditure. The invoice(s) and receipt(s) for election expense(s) may be submitted in separate documents, or may be contained in the same document. The invoice(s) and receipt(s) submitted by candidate must contain the following particulars-

- (a) date
- (b) details of the expense item (i.e. information and amount of the goods or services);
- (c) information of the organization or person (other than the candidate himself/herself) providing the goods or services; and
- (d) information showing that the organization or person (other than the candidate himself/herself) providing the goods or services has received the relevant payment in full (e.g. name and signature of the recipient, or the stamp of the organization or signature of its authorized person).
- 6. 候選人應在所有發票及收據(包括選舉捐贈收據)上<u>順序註明編號</u>,並將編配予每一發票及收據的編號填寫在「發票及收據」/「收據副本」一欄內的相應位置,以資對照。

Candidate should mark all invoices and receipts (including receipts for election donations) in numerical sequence and, for cross-referencing purpose, enter the number assigned to each invoice and receipt in the "Invoice and Receipt"/"Copy of Receipt" column correspondingly.

7. 候選人應根據於中央平台或候選人平台或交給有關界別分組的選舉主任之「選舉廣告資料摘要」 (表格編號:REO/C/10/ECSS(By-E)(SF)(2025))及「修正選舉廣告資料摘要通知書」(表格編號: REO/C/11/ECSS(By-E)(SF)(2025))(如適用)所列的選舉廣告種類及數量填寫此申報書。候選人須計算及申報每一 項選舉廣告的開支。選舉廣告的開支應包括設計及畫稿之費用。如透過互聯網發布選舉廣告(例如電子郵件),與 該選舉廣告相關的費用,例如設計及發布費用及按比例適當分攤的相關互聯網服務費等,應被計算為選舉開支。 Candidate should complete this return based on the types and quantities of election advertisements as stated on the Central Platform or Candidate's Platform or in the "Information Sheet in relation to Election Advertisements" (Form no.: REO/C/10/ECSS(By-E)(SF)(2025)) and "Notification of Corrected Information in relation to Election Advertisements" (Form no.: REO/C/11/ECSS(By-E)(SF)(2025)) (if applicable) submitted to the Returning Officer for the relevant subsector. Candidate should calculate and declare the expense(s) for each and every item of election advertisements. Expenses for election advertisements should include design and artwork fees. If election advertisements are published through the Internet (e.g. electronic mail), fees that are related to such election advertisements, such as design and publication fees and related internet service fee as appropriately apportioned, should be counted as election expenses.

- 候選人應根據因選舉有關用途而招致的租金及辦公室開支金額申報選舉開支。候選人租用辦公室進行競選活動時, 如有關租約指定須要租用該辦公室直至某一期限,而該期限是選舉結束後的一個日期,若有關租賃開支是在選舉期 間招致的,只要該辦公室是一直只用於選舉有關用途,候選人必須將整筆租賃開支計算為選舉開支(包括租約內橫 跨選舉日之後的部分)。假如候選人在選舉日後不再使用該辦公室作選舉有關用途,應將有關租約內涉及選舉日之 後的租賃開支分開計算,並在選舉申報書內說明有關選舉日之後的租賃開支因與選舉無關而不計算在選舉開支內。 此外,如辦公室並非只用於選舉有關用途(例如與其他人士分租或用作議員辦事處),應就選舉有關用途和其他用 途分攤租金及辦公室開支,並將計算方式詳列於選舉申報書。上述安排亦適用於代理人及選舉助理的薪金開支。 Candidate should declare the election expenses based on the amounts of rental and office expenses incurred for election-related purpose. When the candidate rents an office for electioneering purposes, if the lease has specified a rental period beyond the end of the election, and if the relevant rental expense is incurred during the election period, the candidate should include the whole rental expense (including the expense for the rental period after the date of election) as an election expense, if the office concerned is solely used for election-related purpose. If the candidate does not use the office for election-related purpose after the date of election, he/she should apportion the rental expense for the period after the date of election, and state in the election return that the rental expense for the period after the date of election is not for election-related purpose, thus it is not counted as part of the election expenses. Also, if the office is not solely used for election-related purpose (for example, it is shared with other persons or used as a councillor's office), the rental and office expenses should be apportioned between election-related purposes and any other purposes. The calculation should also be stated in detail in the election return. The above arrangement is also applicable to the salary expenses for agents and election assistants.
- 9. 選舉捐贈的形式包括金錢、貨品及服務。不論形式為何,所有已接受的選舉捐贈均須在此申報書及聲明書的相關部分填報。
 - Election donations may take the form of money, goods and services. Regardless of the form they take, all election donations received must be set out under the relevant Section(s) in this return and declaration.
- 10. 凡免費獲得的服務(除義務服務外)或貨品,必須申報為選舉捐贈,並於此申報書內相應地申報其估計的價值為選舉開支。
 - Services (except for voluntary service) or goods obtained free of charge must be declared as election donations, and their estimated value must also be correspondingly declared as election expenses in this return.
- 11. 如候選人以折扣價獲得貨品或服務,而有關折扣並非所有顧客一般可享有,貨品或服務的市價/正常價格與候選人支付的價格差額會被視為一項選舉捐贈,候選人必須將其申報為選舉捐贈,並於此申報書內相應地申報該貨品或服務的市價/正常價格為選舉開支及註明折扣金額。
 - If a candidate obtains goods or services at a discounted price, and the discount is not generally available to all customers, the difference between the market/regular price of goods or services and the price paid by the candidate is to be regarded as an election donation. Candidate must declare such as an election donation, and correspondingly declare the market/regular price of the goods or services as an election expense and specify the amount of discount in this return.
- 12. 如某項選舉捐贈的金額或價值為 1,000 元以上(包括多項來自同一捐贈者而累計總價值為 1,000 元 以上的選舉捐贈),候選人必須發給捐贈者載有該捐贈者的姓名或名稱及地址(一如捐贈者所提供)及該項捐贈的詳情的收據 [「劃一格式選舉捐贈收據」(表格編號:REO/C/2/2025ECSS(By-E)(SDF))],並將收據副本與申報書一併提交。 捐贈者可選擇披露其屬意的地址,如其辦事處或業務地址、通訊地址、住址或郵政信箱號碼。候選人須將捐贈者的 姓名或名稱及地址及捐贈詳情填報於此申報書及聲明書。
 - If the amount or value of an election donation is more than \$1,000 (including multiple election donations from the same donor and total value is more than \$1,000), candidate must issue a receipt ["Standard Receipt for Election Donations" (Form no.: REO/C/2/2025ECSS(By-E)(SDF))] to the donor specifying the name and address of the donor concerned (as supplied by the donor) and giving particulars of the donation concerned, and submit the return together with a copy of such receipt. The donor may choose to disclose an address that he/she/it prefers, for example his/her/its office or business address, correspondence address, residential address or post office box number. Candidate must provide the name(s) and address(es) of donor(s) and particulars of the donations in this return and declaration.
- 13. 選舉捐贈只可用於償付或分擔償付該候選人或該等候選人的選舉開支。如某項選舉捐贈包含貨品或服務,該項捐贈則只可用於促使該候選人或該等候選人當選或阻礙另一名候選人或另一些候選人當選。此外,就尚未用於償付選舉開支的選舉捐贈,候選人必須在呈交此申報書之前按照《選舉(舞弊及非法行為)條例》(第 554 章)第 19(2)-(4)條處置有關選舉捐贈,並在此申報書附上收款人發出的收據副本。否則,候選人須在此申報書附上書面解釋,列出沒有按照該條處置該項或該部分選舉捐贈的理由。

Election donations can only be used for the purpose of meeting, or contributing towards meeting, the election expenses of the candidate or candidates. In the case of an election donation consisting of goods or services, such donation can only be used for the purpose of promoting the election of the candidate or candidates or of prejudicing the election of another candidate or other candidates. Moreover, the unused election donation(s) must be disposed of in accordance with section 19(2)-(4) of the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554) before this return is lodged. The said return must be accompanied by copy(ies) of the receipt(s) given by the recipient(s) thereof; otherwise, the return must be accompanied by a written explanation setting out the reason why such election donation or part of it was not disposed of in accordance with that section.

14. 候選人必須在《選舉(舞弊及非法行為)條例》(第 554 章)第 37(1D)及(1E)條規定的限期屆滿之前,將填妥的申報書及聲明書(連同附件,如有)提交予總選舉事務主任(地址:九龍觀塘觀塘道 392 號創紀之城 6 期 23 樓 2301-03 室選舉事務處)。

Candidate must submit the completed return and declaration (and attachments, if any) by the statutory deadline as required under section 37(1D) and (1E) of the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554) to the Chief Electoral Officer (Address: Registration and Electoral Office, Unit 2301-03, 23/F, Millennium City 6, 392 Kwun Tong Road, Kwun Tong, Kowloon).

15. 此申報書及聲明書以及所有附件的副本將備存於選舉事務處,由該申報書及聲明書提交總選舉事務主任的時間起,直至根據《選舉(舞弊及非法行為)條例》(第 554 章)第 41 條規定申報書及聲明書可供公眾查閱的期間完結為止,供公眾查閱或提供予索閱有關文件的人士。在展示前,此申報書及聲明書連同所有附件內所有個人資料(捐贈者的姓名及地址除外)將會被遮蓋。

Copies of this return and declaration and all attachments will be kept at the Registration and Electoral Office and made available for public inspection or may be furnished to any person requesting for the relevant documents from the time when the return and declaration concerned is lodged with the Chief Electoral Officer until the end of the period for which copies of election returns and declarations are to be made available for public inspection under section 41 of the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554). All personal data (except the name(s) and address(es) of the donor(s)) in this return and declaration and all attachments will be covered before display.

16. 選舉事務處將查核所有候選人提交的申報書及聲明書。倘若發現任何不當情況,將會向有關當局報告,以進行調查。候選人在申報書及聲明書上填報的資料亦可能供給有關當局進行調查。

The Registration and Electoral Office will check all returns and declarations submitted by candidates. Any irregularities detected will be reported to the relevant authorities for investigation. The information provided by candidates in their returns and declarations may also be provided to the relevant authorities for investigation.

17. 《選舉(舞弊及非法行為)條例》(第554章)與選舉申報書相關的部分條文載列如下,以供參考-

Part of the provisions of the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554) concerning election return are reproduced below for reference -

《選舉(舞弊及非法行為)條例》(第554章)第2條

「選舉開支」(election expenses) 就某項選舉的候選人而言,指在選舉期間前、在選舉期間內或在選舉期間後,由該候選人或由他人代該候選人一

- (a) 為促使該候選人當選;或
- (b) 為阻礙另一候選人當選,

而招致或將招致的開支,並包括包含貨品及服務而用於上述用途的選舉捐贈的價值。

「選舉捐贈」(election donation) 就某項選舉的一名或多於一名候選人而言,指以下任何捐贈-

- (a) 為償付或分擔償付該候選人或該等候選人的選舉開支,而給予該候選人或該等候選人或就該候選人或該等候選 人而給予的任何金錢;或
- (b) 為促使該候選人或該等候選人當選或阻礙另一名候選人或另一些候選人當選,而給予該候選人或該等候選人或 就該候選人或該等候選人而給予的任何貨品,包括由於提供義務服務而附帶給予的貨品;
- (c) 為促使該候選人或該等候選人當選或阻礙另一名候選人或另一些候選人當選,而向該候選人或該等候選人提供 或就該候選人或該等候選人而提供的任何服務,但不包括義務服務。

「義務服務」(voluntary service) 指任何自然人為以下目的在其私人時間自願親自免費向某項選舉的一名或多於一名候選人提供或就某項選舉的一名或多於一名候選人而提供的任何服務-

- (a) 促使該候選人或該等候選人當選;或
- (b) 阻礙另一名候選人或另一些候選人當選。

Section 2 of the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554)

"Election expenses" (選舉開支), in relation to a candidate at an election, means expenses incurred or to be incurred, before, during or after the election period, by or on behalf of the candidate for the purpose of –

- (a) promoting the election of the candidate; or
- (b) prejudicing the election of another candidate,

and includes the value of election donations consisting of goods and services used for that purpose.

"Election donation" (選舉捐贈), in relation to a candidate or candidates at an election, means any of the following donations –

- (a) any money given to or in respect of the candidate or candidates for the purpose of meeting, or contributing towards meeting, the election expenses of the candidate or candidates;
- (b) any goods given to or in respect of the candidate or candidates for the purpose of promoting the election of the candidate or candidates or of prejudicing the election of another candidate or other candidates, and includes any goods given incidental to the provision of voluntary service;
- (c) any service provided to or in respect of the candidate or candidates for the purpose of promoting the election of the candidate or candidates or of prejudicing the election of another candidate or other candidates, but does not include voluntary service.
- "Voluntary service" (義務服務) means any service provided free of charge to or in respect of a candidate or candidates at an election by a natural person, voluntarily and personally, in the person's own time for the purpose of –
- (a) promoting the election of the candidate or candidates; or
- (b) prejudicing the election of another candidate or other candidates.

《選舉(舞弊及非法行為)條例》(第554章)第19條

- (1) 如某候選人收取或某些候選人共同收取的某項選舉捐贈為\$1,000 以上或(如該項選舉捐贈包含貨品或服務)價值\$1,000 以上,則該候選人或該等候選人必須就該項捐贈向捐贈者發出收據。該收據必須載明捐贈者提供的捐贈者的姓名或名稱及地址。
- (2) 如給予某候選人或某些候選人或就某候選人或某些候選人而給予的某項選舉捐贈為\$1,000 以上或(如該項選舉捐贈包含貨品)價值\$1,000 以上,而該候選人或該等候選人不知道捐贈者的姓名或名稱及地址,則該候選人或該等候選人必須確保一
 - (a) 該項捐贈不會用於一
 - (i) 償付或分擔償付該候選人或任何該等候選人的選舉開支;或
 - (ii)(如該項捐贈包含貨品)促使該候選人或任何該等候選人當選或阻礙另一名候選人或另一些候選人當選;及
 - (b) 將該項捐贈給予該候選人或該等候選人所選擇的屬公共性質的慈善機構或慈善信託。
- (3) 如給予某候選人或某些候選人或就某候選人或某些候選人而給予的某項選舉捐贈屬金錢或貨品,而該項捐贈— (a) 沒有用於一
 - (i) 償付或分擔償付該候選人或該等候選人的選舉開支;或
 - (ii)(如該項捐贈包含貨品)促使該候選人或該等候選人當選或阻礙另一名候選人或另一些候選人當選;或
 - (b) 在第(2)款所提述的情況下不會用於該款(a)(i)或(ii)段所述用途,
 - 則該候選人或該等候選人必須確保將該項捐贈給予該候選人或該等候選人所選擇的屬公共性質的慈善機構或慈善信託。
- (4) 如給予某候選人或就某候選人而給予的所有選舉捐贈的總額超過根據第 45 條訂明的最高限額,則該候選人必須確保將超額部分(不包括屬服務性質的選舉捐贈)給予該候選人所選擇的屬公共性質的慈善機構或慈善信託。
- (5) 凡某候選人收取或某些候選人共同收取選舉捐贈,如—
 - (a) 該候選人或該等候選人沒有遵從第(1)或(2)款;或
 - (b) 該候選人在按照第 37 條提交選舉申報書之前,或該等候選人在每名該等候選人按照第 37 條提交選舉申報書之前,沒有遵從本條的其他規定,

則該候選人或每名該等候選人即屬在選舉中作出舞弊行為。

(6) 在本條中,「屬公共性質的慈善機構或慈善信託」(charitable institution or trust of a public character) 指根據《稅 務條例》(第112章)第88條獲豁免繳稅的屬公共性質的慈善機構或慈善信託。

Section 19 of the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554)

- (1) A candidate or candidates must, on receiving an election donation of more than \$1,000 or, in the case of an election donation consisting of goods or a service, of more than \$1,000 in value, issue to the donor a receipt for the donation. The receipt must specify the name and address of the donor as supplied by the donor.
- (2) If an election donation of more than \$1,000 or, in the case of an election donation consisting of goods, of more than \$1,000 in value, is given to or for a candidate or candidates and the candidate or candidates do not know the name and address of the donor, the candidate or candidates must ensure that the donation
 - (a) is not used
 - (i) for the purpose of meeting, or contributing towards meeting, the election expenses of the candidate or any of the candidates; or
 - (ii) in the case of an election donation consisting of goods, for the purpose of promoting the election of the candidate or any of the candidates or of prejudicing the election of another candidate or other candidates; and
 - (b) is given to a charitable institution or trust of a public character chosen by the candidate or candidates.
- (3) If an election donation of money or goods has been given to or for a candidate or candidates and the donation
 - (a) has not been used
 - (i) for the purpose of meeting, or contributing towards meeting, the election expenses of the candidate or candidates; or
 - (ii) in the case of an election donation consisting of goods, for the purpose of promoting the election of the candidate or candidates or of prejudicing the election of another candidate or other candidates; or
 - (b) is not used in the case referred to in subsection (2),
 - the candidate or candidates must ensure that the donation is given to a charitable institution or trust of a public character chosen by the candidate or candidates.
- (4) If the aggregate of all election donations given to or for a particular candidate exceeds the maximum amount prescribed under section 45, the candidate must ensure that the excess (not including election donations of services) is given to a

- charitable institution or trust of a public character chosen by the candidate.
- (5) If an election donation is received by a candidate or candidates, the candidate or each of the candidates engages in corrupt conduct at an election if—
 - (a) the candidate or candidates fail to comply with subsection (1) or (2); or
 - (b) the candidate or candidates fail to comply with any other requirement of this section before the time when the candidate's or each candidate's election return for the election is lodged in accordance with section 37.
- (6) In this section, "charitable institution or trust of a public character"(屬公共性質的慈善機構或慈善信託) means a charitable institution or trust of a public character that is exempt from tax under section 88 of the Inland Revenue Ordinance (Cap. 112).

《選舉(舞弊及非法行為)條例》(第554章)第37(1),(1D),(1E)及(2)(b)條

- (1) 在選舉中的每名候選人必須向有關主管當局提交選舉申報書,列出一
 - (a) 該候選人在該項選舉中的選舉開支;及
 - (b) 曾由該候選人或由他人代該候選人在與該項選舉有關連的情況下收取的所有選舉捐贈。
- (1D) 就為選出選舉委員會委員而舉行的選舉而言,候選人須確保申報書在以下情況出現當日後的 30 日期間屆滿前 提交一
 - (a) 如按根據《選舉管理委員會(選舉程序)(選舉委員會)規例》(第 541 章,附屬法例 I)第 4 條刊登的公告,該選舉是某些同日舉行的界別分組選舉的其中之一-該等界別分組選舉均已告結束(如該等界別分組選舉在不同日期結束,則以該等日期中的最後者為準);或
 - (b) 如屬其他情況-該選舉已告結束。
- (1E) 為施行第(1D)款,選舉在任何以下事件就該選舉發生當日,即告結束-
 - (a) 選舉結果於憲報公布;
 - (b) 宣布沒有候選人獲有效提名。
- (2) 候選人必須確保申報書-
 - (b) 附有-
 - (i) (就每項\$500 或以上的選舉開支而言)載有該項支出的詳情的發票及收據;及
 - (ii) (就每項\$1,000 以上或每項包含貨品或服務而價值\$1,000 以上的選舉捐贈而言)發給捐贈者的載有關 於該捐贈者及該項捐贈的詳情的收據的副本;及
 - (iii) (如由候選人或由他人代候選人在與選舉有關連的情況下收取的某項選舉捐贈或某項選舉捐贈的一部 分沒有用於該用途而已按照第19條處置)收取該等如此處置的捐贈或部分捐贈的人所發出的收據的副 本;及
 - (iv) (如由候選人或由他人代候選人在與選舉有關連的情況下收取的某項選舉捐贈或某項選舉捐贈的一部 分沒有用於該用途,亦沒有按照第 19(3)條處置)書面解釋,列出沒有按照該條處置該項捐贈或該部分 捐贈的理由;及
 - (v) 採用有關主管當局提供或指明的表格或格式所作的聲明書,證明申報書內容屬實。

Section 37(1), (1D), (1E) and (2)(b) of the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554)

- (1) Each candidate at an election must lodge with the appropriate authority an election return setting out
 - (a) the candidate's election expenses at the election; and
 - (b) all election donations received by or on behalf of the candidate in connection with the election.

 - (iv) where an election donation or part of an election donation that was received by or on behalf of the candidate in connection with the election was not used for that purpose was not disposed of in accordance with section 19(3), by an explanation setting out the reason why it was not disposed of in accordance with that section;

and

(v) by a declaration in a form provided or specified by the appropriate authority verifying the contents of the return







If the aggregate amount or value of all election donations exceeds the prescribed maximum amount of election expenses that can be incurred by the candidate by law at an election, or remains unused in whole or in part after the election for the purpose of meeting the election expenses of the candidate, or in the case of an election donation consisting of goods, for the purpose of promoting the election of the candidate or of prejudicing the election of another candidate or other candidates, the candidate must ensure that the excess or unused election donation (not including election donations of services) is given to charitable institution(s) or trust(s) of a public character chosen by the candidate.
