(I) 申請開立中央平台戶口**Application for an Account on the Central Platform****參考／表格

- (1) 候選人在使用中央平台遞交選舉廣告前，請將已填妥的表格「中央平台戶口申請表及有關候選人使用中央平台的條款及細則的承諾書」（表格編號：REO/C/10A/ECSS(SF)(2026)（「申請表」）送交總選舉事務主任。候選人可在選舉事務處網頁下載最新版本的申請表：

- (2) 總選舉事務主任會於收到申請表的 **3 個工作天內**，將用戶名稱透過電郵發送至候選人提供的電郵地址。而兩個登入密碼則會以短訊發送至候選人提供的手提電話號碼。

Upon receipt of the Application Form, the CEO will inform the candidate **within 3 working days** of the username through the email address provided by the candidate. Two login passwords will be sent by short message service (“SMS”) to the mobile phone number provided by the candidate.

If a candidate uploads the hyperlink of a website on which an EA is published onto the Central Platform, he/she must ensure the hyperlink is valid and the relevant website continues to operate until the end of the period for which copies of Election Returns are available for inspection pursuant to section 41 of the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554), so as to allow public inspection of the EAs.

事例（六） Case 6

候選人於 10 月 24 日共印刷 3,000 張傳單，並於 10 月 25 日於街頭派發其中 1,000 張。候選人已於 10 月 26 日透過中央平台遞交選舉廣告詳情。惟候選人其後發現 10 月 25 日於街頭派發的傳單數目應修正為 500 張，而餘下的 500 張則於 10 月 27 日以郵寄方式分發。

在此情況下，

- (1) 候選人須先於中央平台修改於 10 月 25 日派發的選舉廣告的詳情，將街頭派發的傳單數目由 1,000 改為 500。有關修正資料應參照例 6.1 的方式填寫。

A candidate printed 3,000 copies of handbills in total on 24 October and distributed 1,000 copies of the handbills on the street on 25 October. The candidate provided the EA particulars via the Central Platform on 26 October. However, the candidate later noticed that the number of handbills distributed on the street on 25 October should be 500 instead, and the remaining 500 were distributed on 27 October by post.

In this case,

- (1) the candidate is required to correct on the Central Platform the EA particulars distributed on 25 October by changing the number of handbills distributed on the street from 1,000 to 500. The correction should be done as shown in **Example 6.1**.

- (2) 餘下 500 張於 10 月 27 日以郵寄方式分發的傳單，由於發布的方式不同，應被視為發布新的選舉廣告。候選人須就以郵寄方式分發的傳單於 10 月 30 日或之前，透過中央平台遞交新的選舉廣告詳情及上載該郵寄單張的電子文本，並非進一步修正之前已上載的選舉廣告詳情。遞交新的選舉廣告詳情的方式應參照例 6.2 的方式填寫。
- (2) Regarding the remaining 500 handbills that were distributed by post on 27 October, they should be regarded as publishing a new EA as the handbills were distributed in a different manner. Instead of further correcting the EA particulars provided previously, the candidate is required to provide new EA particulars and upload an electronic copy of the handbills sent by post via the Central Platform by 30 October in respect of such handbills distributed by post. The new EA particulars should be filled in as shown in **Example 6.2**.

(1) A candidate produced 10 banners without candidate number on 24 October and displayed them on roadside railing on 25 October (assuming 25 October is a Sunday). The candidate is required to provide the EA particulars onto the Central Platform by 28 October. The EA particulars should be filled in as shown in **Example 7.1**.

Therefore, the candidate is required to correct the EA particulars provided previously by uploading the electronic copy of the EA with stickers on it via the Central Platform, not later than 3 working days after the polling day. The correction should be done as shown in Example 7.2.

事例（八） Case 8

候選人於 10 月 24 日製作 10 張只有其姓名及圖像的橫額，並於 10 月 25 日在街頭展示。候選人於 10 月 26 日已透過中央平台上載選舉廣告詳情。候選人其後於 10 月 27 日於該橫額貼上新標語。

由於新貼上新標語的橫額所顯示的內容與原來的橫額有不同，所以應被視為一個新的選舉廣告。因此候選人須於 10 月 30 日或之前透過中央平台上載新的選舉廣告詳情及選舉廣告電子文本，而不是修正之前發布的選舉廣告詳情。新的選舉廣告詳情應參照例 8.1 的方式填寫。

A candidate produced 10 banners only with his/her name and image on 24 October and displayed them on the street on 25 October. The candidate provided the EA particulars via the Central Platform on 26 October. The candidate later stuck new slogans on those banners on 27 October.

As the contents on the banners with new slogans are different from the previous one, the banners with new slogans should be regarded as a new EA. The candidate is required, instead of correcting the particulars of the EA provided previously, to provide new EA particulars and an electronic copy of the new EA via the Central Platform by 30 October. The new EA particulars should be filled in as shown in **Example 8.1**.
