## Procedural Guide on Submission of Election Advertisements onto the Central Platform

本程序指引是根據「區議會選舉活動指引」第七章及附錄二有關呈交選舉廣告及有關資料擬定。 This procedural guide is provided for the submission of election advertisements ("EAs") and relevant information in accordance with Chapter 7 and Appendix B of the "Guidelines on Election-related Activities in respect of the District Council Election".

## (I) 申請用戶 Application for an Account

(1) 候選人在使用中央平台呈交選舉廣告前,請將已填妥的表格「中央平台戶口申請表及有關候選人使用中央平台的條款及細則的承諾書」(REO/C/10A/DC(SF)(2017))的正本以專人送遞或郵遞送交總選舉事務主任(地址:九龍觀塘觀塘道392號創紀之城6期23樓2301-3室)。候選人可在選舉事務處網頁下載最新版本的申請表: http://www.reo.gov.hk REO/C/10A/ DC(SF)(2017)

Candidate should submit to the Chief Electoral Officer ("CEO") the original of the completed form "Application for Creating an Account of the Central Platform and Undertaking in respect of the Terms and Conditions in Using the Central Platform for Candidates" (REO/C/10A/DC(SF)(2017)) by hand or by post (Address: Unit 2301-3, 23/F, Millennium City 6, 392 Kwun Tong Road, Kwun Tong, Kowloon) before he/she can access the Central Platform to submit any EA particulars. (2) 總選舉事務主任會於收到申請表的<u>三個工作天內</u>,將用戶名稱透過電郵發送至申請人提供的電郵地址。而兩個登入密碼則會以短訊發送至申請人提供的手提電話號碼。

Upon receipt of the application form, the CEO will inform the applicant **within 3 working days** the username through the email address provided by the applicant. The 2 login passwords will also be sent to the applicant by short message service ("SMS") at the mobile phone number provided in the application form.

If the candidate(s) upload(s) the hyperlink of a website on which an EA is published onto the Central Platform, he/she must ensure the hyperlink is valid and the relevant website continues to operate until the end of the period for which copies of election returns are available for inspection pursuant to section 41 of the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554), so as to facilitate public inspection of EAs.

在此情況下,候選人須最遲於投票日後兩個工作天內透過中央平台修正該選舉廣告詳情。候選人只須填寫須修改的項目,而無須重新填寫其他並不需要修正的項目。有關修正資料應以下列**例 4.1** 的方式填寫。

A candidate printed and distributed 3,000 copies of handbills in total on 21 November, and submitted the EA particulars via Central Platform on 23 November. However, the candidate later found that the number of handbills distributed should be 2,000 instead of 3,000.

In this case, the candidate has to correct such EA particulars via Central Platform not later than 2 working days after the polling day. The candidate should only fill in the information to be corrected and does not need to fill in other items which no correction is required. The correction should be done as shown in **Example 4.1** below.

### <u>事例(五)Case 5</u>

候選人於 11 月 21 日共印刷及派發 3,000 張傳單,並已於 11 月 23 日透過中央平台遞交選舉廣告詳情。惟候選人其後發現錯誤上載另一張傳單的電子文本。

在此情況下,候選人須最遲於投票日後兩個工作天內透過中央平台修正該選舉廣告詳情,重新上載正確的傳單的電子文本。有關修正資料應以下列**例 5.1** 的方式填寫。

A candidate printed and distributed 3,000 copies of handbills in total on 21 November, and submitted the EA particulars via Central Platform on 23 November. However, the candidate later found that he/she had wrongly uploaded the electronic copy of another handbill.

In this case, the candidate has to correct such EA particulars via Central Platform by uploading the electronic copy of the correct handbill not later than 2 working days after the polling day. The correction should be done as shown in **Example 5.1** below.

## 事例 (六) Case 6

候選人於 11 月 21 日共印刷 3,000 張傳單,並於 11 月 22 日於街頭派發其中 1,000 張。候選人已於 11 月 23 日透過中央平台遞交選舉廣告詳情。惟候選人其後表示 11 月 22 日於街頭派發的傳單數目應修正為 500 張,而餘下的 500 張於 11 月 24 日以郵寄方式分發。

### 在此情况下,

(1) 候選人須先於中央平台修改於 11 月 22 日派發的選舉廣告的詳情,將街頭派發的傳單數目由 1,000 改為 500。有關修正資料應以**例 6.1** 的方式填寫。

A candidate printed 3,000 copies of handbills in total on 21 November and distributed 1,000 copies of the handbills on the streets on 22 November. The candidate submitted the EA particulars via Central Platform on 23 November. However, the candidate later stated that the number of handbills distributed on the streets on 22 November should be 500 instead, and the remaining 500 were distributed on 24 November by post.

#### In this case,

(1) the candidate should first correct on Central Platform the EA particulars distributed on 22 November by changing the number of handbills distributed on the streets from 1,000 to 500. The correction should be done as shown in **Example 6.1** below.

- (2) 另外 500 張於 11 月 24 日以郵寄方式分發的傳單,由於發布方式不同,應被視為發布新的選舉廣告。候選人應就該等以郵寄方式分發的傳單於 11 月 25 日或之前,透過中央平台遞交新的選舉廣告詳情及上載該郵寄單張的電子文本,而不是進一步修正之前已上載的選舉廣告詳情。遞交新的選舉廣告詳情的方式應以下列例 6.2 的方式填寫。
- (2) Regarding the 500 handbills distributed by post on 24 November, they should be regarded as a new EA as the handbills were distributed in a different manner. Instead of further correcting the EA particulars submitted previously, the candidate should in respect of such handbills that were distributed by post, submit by 25 November new EA particulars and upload an electronic copy of the handbills sent by post via Central Platform. The new EA particulars should be filled in as shown in **Example 6.2** below.

- (1) 候選人於 11 月 21 日製作 10 張沒有加上候選人編號的橫額,於 11 月 22 日懸掛並在路邊 鐵欄展示。候選人應於 11 月 23 日或之前將選舉廣告詳情上載中央平台。有關選舉廣告詳 情應以下列**例 7.1** 的方式填寫。
- (1) A candidate produced 10 banners without candidate number on 21 Novmeber and displayed them on roadside railing on 22 November. The candidate should submit the EA particulars onto the Central Platform on or before 23 November. The EA particulars should be filled in as shown in **Example 7.1** below.

- (2) 候選人其後於 12 月 2 日在橫額貼上候選人編號標貼。雖然候選人編號標貼本身不會被視為一份選舉廣告,但候選人曾就原有的選舉廣告作出修改。因此候選人須最遲於投票日後兩個工作天內,透過中央平台上載已貼上編號標貼之選舉廣告的電子文本,以修正已遞交的選舉廣告詳情。有關修正資料應以下列例 7.2 的方式填寫。
- (2) Subsequently, the candidate stuck candidate number stickers on the banners on 2 December. Though the candidate number sticker is not an EA itself, the original EA was amended. Therefore, the candidate should correct the EA particulars submitted previously by uploading the electronic copy of the EA with stickers on it via the Central Platform, within 2 working days after the polling day, the latest. The correction should be done as shown in **Example 7.2** below.

#### 事例(八) Case 8

候選人於 11 月 21 日製作 10 張只有其姓名及圖像的橫額,並於 11 月 22 日在街頭展示。候選人於 11 月 23 日已透過中央平台上載選舉廣告詳情。候選人其後於 11 月 24 日於該橫額貼上新標語。

由於新舊橫額所顯示的內容不同,被貼上標語的橫額應被視為一個新的選舉廣告。因此候選人應於11月25日或之前透過中央平台上載新的選舉廣告詳情及選舉廣告電子文本,而不是修正之前發布的選舉廣告詳情。新的選舉廣告詳情應以下列**例8.1**的方式填寫。

A candidate produced 10 banners only with his/her name and image on 21 November, and displayed them on the street on 22 November. The candidate submitted the EA particulars via Central Platform on 23 November. The candidate later stuck new slogans on those banners on 24 November.

As the content on the previous and new banners are different, the banners with new slogans should be regarded as new EAs. The candidate, instead of correcting the EA particulars submitted previously, should submit new EA particulars and an electronic copy of the new EA via Central Platform by 25 November. The new EA particulars should be filled in as shown in **Example 8.1** below.
