

使用印本形式呈交選舉廣告作公眾查閱須知
Notes on Submission of Election Advertisements in Hard Copies for Public Inspection

為符合在現行的選舉條例及指引下有關公眾查閱的要求，候選人須以選舉管理委員會指明的方式及時間內，即於**發布選舉廣告後的三個工作天內**，向選舉主任提供**有關選舉廣告的印本及有關的資料／文件（包括准許／授權或支持同意書）**，或上載選舉廣告的電子文本及有關的資料／文件到由總選舉事務主任所設辦的公開平台（即「中央平台」）或由候選人所設辦的公開平台（即「候選人平台」），供公眾查閱。如候選人選擇以印本形式向有關選舉主任呈交選舉廣告作公眾查閱，請細閱《選舉委員會界別分組選舉活動指引》第八章及參考以下常見例子。候選人可於選舉事務處的網頁（<https://www.reo.gov.hk>）下載最新版本的「選舉廣告資料摘要」（“資料摘要”）（REO/C/10/ECSS(By-E)(SF)(2025)）及「修正選舉廣告資料摘要通知書」（“修正通知書”）（REO/C/11/ECSS(By-E)(SF)(2025)）。

Under the current electoral legislation and guidelines, to comply with the public inspection requirement, a candidate may provide **hard copies of his/her Election Advertisements (“EAs”) and the relevant information/documents (including permission/authorization or Consent of Support)**, with Returning Officers (“ROs”), or upload the electronic copies and relevant information/documents onto an open platform maintained by the Chief Electoral Officer (referred to as “Central Platform”) or an open platform maintained by the candidate (referred to as “Candidate’s Platform”) for public inspection in the manner and time specified by the Electoral Affairs Commission (i.e. **within 3 working days after the publication of the EAs**). If the candidate chooses to provide hard copies of the EAs to the relevant RO for public inspection, he/she should read Chapter 8 of the “Guidelines on Election-related Activities in respect of the Election Committee Subsector Elections” and make reference to the following common examples. The candidate may download the latest version of the “Information Sheet in relation to Election Advertisements” (“Information Sheet”) (REO/C/10/ECSS(By-E)(SF)(2025)) and “Notification of Corrected Information in relation to Election Advertisements” (“Notification of Correction”) (REO/C/11/ECSS(By-E)(SF)(2025)) from the website of the Registration and Electoral Office (<https://www.reo.gov.hk>).

事例（一）Case 1

候選人於 8 月 23 日共印刷 3,000 張傳單，並在 8 月 24 日（假設 8 月 24 日為星期日）於街頭派發其中 1,000 張傳單。

候選人須於 8 月 27 日或之前（即發布該選舉廣告日期後的三個工作天內）向選舉主任提供資料摘要，並提供兩份有關選舉廣告的樣本，供公眾查閱。有關資料摘要應參照例 1.1 的方式填寫。

A candidate printed 3,000 copies of handbills in total on 23 August, and distributed 1,000 copies of the handbills on the streets on 24 August (assuming 24 August is a Sunday).

The candidate is required to provide the Information Sheet and 2 hard copies of the EA sample to the RO for public inspection by 27 August (i.e. within 3 working days after the date on which the EA is first published). The Information Sheet should be filled in with reference to **Example 1.1**.

若候選人於 8 月 25 日於街頭再派發餘下的 2,000 張傳單，候選人須於 8 月 28 日或之前（即發布該選舉廣告日期後的三個工作天內）向選舉主任提供資料摘要，並提供兩份有關選舉廣告的樣本供公眾查閱。有關資料摘要應參照例 1.2 的方式填寫。

If the candidate distributed the remaining 2,000 copies of handbills on the streets on 25 August, the candidate is required to provide the Information Sheet and 2 hard copies of the EA sample to the RO for public inspection by 28 August (i.e. within 3 working days after the date on which the EA is published). The Information Sheet should be filled in with reference to **Example 1.2**.

事例（二）Case 2

候選人於 8 月 23 日共印刷 3,000 張海報，並於 8 月 24 日（假設 8 月 24 日為星期日）在 20 座大廈每座張貼一張海報。

候選人須於 8 月 27 日或之前向選舉主任提供資料摘要，並提供兩份有關選舉廣告的樣本及一份有關大廈事先發出的書面准許／授權文本，供公眾查閱。有關資料摘要應參照例 2.1 的方式填寫。

A candidate printed 3,000 copies of posters in total on 23 August, and displayed a poster each at 20 buildings on 24 August (assuming 24 August is a Sunday).

The candidate is required to provide the Information Sheet, 2 hard copies of the EA sample and a copy of the prior written permission/authorization issued by the relevant buildings to the RO for public inspection by 27 August. The Information Sheet should be filled in with reference to **Example 2.1**.

事例（三） Case 3

候選人於 8 月 24 日自製一份電子版的海報，並將有關電子海報透過以下的電子方式發布。候選人在填寫資料摘要時可參考以下例子：

A candidate created an electronic copy of a poster on 24 August and published it via the following electronic means. The candidate may make reference to the following examples when completing the Information Sheet –

- (1) 如候選人將電子海報在同日於一個或多於一個社交媒體發布（例如：Facebook、Instagram 等），他／她可向選舉主任提供資料摘要，在「發布的方式」一欄列出有關社交媒體名稱，並提供該選舉廣告一式兩份全彩色相片／打印本／影印本，供公眾查閱（請參考例 3.1 項目編號 1）。但是，若候選人於同日另以電郵及 WhatsApp 等形式將該電子海報傳送給 100 位支持者，由於發布的方式不同，應被視為發布新的選舉廣告，該候選人須另行填寫選舉廣告詳情，並提供該選舉廣告一式兩份全彩色相片／打印本／影印本，供公眾查閱（請參考例 3.1 項目編號 2）。

If the candidate published the electronic poster via one or more than one social media on the same date (e.g. Facebook, Instagram, etc.), he/she may provide the RO with the Information Sheet setting out the name(s) of the social media concerned under the “Manner of publication”, and 2 full colour photographs/printouts/photocopies of the EA for public inspection (please refer to **Item 1 of Example 3.1**). However, if the candidate also sent the electronic poster to 100 supporters via electronic mail and WhatsApp etc. on the same date, it should be regarded as publishing a new EA as the poster was published in a different manner. As such, that candidate is required to fill the EA particulars in a separate row and provide 2 full colour photographs/printouts/photocopies of the EA to the RO for public inspection (please refer to **Item 2 of Example 3.1**)

- (2) 如候選人將電子海報在不同日期於不同的社交媒體發布（例如：在 8 月 24 日於 Facebook 發布，在 8 月 25 日於 Instagram 發布），候選人可於 8 月 27 日及 8 月 28 日分別提供該 Facebook 及 Instagram 有關的資料摘要並連同該選舉廣告一式兩份全彩色相片／打印本／影印本予選舉主任，供公眾查閱。此外，候選人亦可於 8 月 27 日前參照**例 3.2** 的方式一併提供 Facebook 及 Instagram 有關的資料摘要並連同該選舉廣告一式兩份全彩色相片／打印本／影印本予選舉主任，供公眾查閱。

If the candidate published the electronic poster on **different** dates on **different** social media (e.g. published on Facebook on 24 August and on Instagram on 25 August), the candidate may provide the Information Sheet and 2 full colour photographs/printouts/photocopies of the EA to the RO for public inspection by 27 August (Facebook) and 28 August (Instagram). Alternatively, the candidate may, referring to **Example 3.2**, provide the Information Sheet and 2 full colour photographs/printouts/photocopies of the EA to the RO in one submission for public inspection by 27 August.

事例（四）Case 4

候選人於 8 月 23 日共印刷 3,000 張傳單，並於 8 月 24 日在街頭派發有關傳單。候選人已於 8 月 25 日向選舉主任提供資料摘要及有關傳單的樣本供公眾查閱。惟候選人其後發現派發的傳單數量應為 2,000 張，而非先前填寫的 3,000 張。

在此情況下，候選人須最遲於投票日後三個工作天內向選舉主任提供修正通知書，以修改該選舉廣告的詳情。候選人須在修正通知書中的**第 1 頁第 1 段**列明需修正的資料摘要**遞交的日期**，以便選舉主任對照有關選舉廣告，然後在第 2 頁有關的項目修正資料填寫表編號、項目號碼及須修改的項目，而無須重新填寫其他並不需要修改的項目。有關修正通知書應參照**例 4.1**的方式填寫。

A candidate printed 3,000 copies of handbills in total on 23 August and distributed them on 24 August. The candidate provided the Information Sheet and the samples of the handbills to RO for public inspection on 25 August. However, the candidate later found that the number of handbills distributed should be 2,000 instead of 3,000.

In this case, the candidate has to correct such EA particulars by providing the Notification of Correction to the RO not later than 3 working days after the polling day. The candidate should state the **date of submission** of the Information Sheet to be corrected in **paragraph 1 of page 1** of the Notification of Correction for RO's reference. The candidate should only fill in the table number, item number and the information of the relevant items to be corrected on page 2, does not need to fill in other items which correction is not required. The Notification of Correction should be filled in with reference to **Example 4.1**.

在此情況下，候選人須最遲於投票日後三個工作天內向選舉主任提供修正通知書，並重新向選舉主任提供兩份正確的選舉廣告樣本。候選人須在修正通知書中的**第 1 頁第 1 段**列明需修正的資料摘要**遞交的日期**，以便選舉主任對照有關選舉廣告，然後在第 2 頁有關的項目修正資料填寫「更改選舉廣告樣本」。有關修正通知書應參照**例 5.1**的方式填寫。

A candidate printed 3,000 copies of handbills in total on 23 August and distributed them on 24 August. The candidate provided the Information Sheet and the EA samples to the RO for public inspection on 25 August. However, the candidate later found that he/she had wrongly provided the RO with the samples of another handbill.

In this case, the candidate has to provide a Notification of Correction and 2 correct EA samples to the RO not later than 3 working days after the polling day. The candidate is required to state the **date of submission** of the Information Sheet to be corrected in **paragraph 1 of page 1** of the Notification of Correction for RO's reference. Then fill in "correction of EA samples" in the corrected information of the relevant items on page 2. The Notification of Correction should be filled in with reference to **Example 5.1**.

A candidate printed 3,000 copies of handbills in total on 23 August and distributed 1,000 copies of the handbills on the streets on 24 August. The candidate provided the Information Sheet and EA samples to RO on 25 August. However, the candidate later noticed that the number of handbills distributed on the streets on 24 August should be 500 instead, and the remaining 500 were distributed on 26 August by post.

Regarding the remaining 500 handbills that were distributed by post on 26 August, they should be regarded as publishing a new EA as the handbills were distributed in a different manner. Instead of correcting the particulars of the submitted EAs, the candidate is required, in respect of such handbills that were distributed by post, to provide a new Information Sheet and 2 copies of the relevant EA sample to the RO by 29 August. The Information Sheet should be filled in with reference to **Example 6.2**.

A candidate produced 10 banners without candidate number on 23 August and displayed them on roadside railing on 24 August (assuming 24 August is a Sunday). The candidate is required to provide the Information Sheet to the RO and 2 full colour photographs of the EA by 27 August. The Information Sheet should be filled in with reference to **Example 7.1**.

Subsequently, the candidate stuck candidate number stickers on the banners on 2 September. Though the candidate number sticker is not an EA itself, the original EA was amended. Therefore, the candidate is required to provide the RO with the Notification of Correction and 2 full colour photographs of the EA with stickers on it, not later than 3 working days after the polling day. The Notification of Correction should be filled in with reference to **Example 7.2**.

候選人於 8 月 23 日製作 10 張只有其姓名及圖像的橫額，並於 8 月 24 日在街頭展示。候選人於 8 月 25 日已向選舉主任提供資料摘要及該選舉廣告一式兩份全彩色相片。候選人其後於 8 月 26 日於該橫額貼上新標語。

由於新貼上新標語的橫額所顯示的內容與原來的橫額不同，所以應被視為一個新的選舉廣告。因此候選人須於 8 月 29 日或之前向選舉主任提供一份新的資料摘要，並提供有關新的選舉廣告一式兩份全彩色相片，而不是填寫修正通知書以修正之前發布的選舉廣告詳情。有關資料摘要應參照例 8.1 的方式填寫。

A candidate produced 10 banners only with his/her name and image on 23 August, and displayed them on the street on 24 August. The candidate provided the Information Sheet and 2 full colour photographs of the EA to RO by 25 August. The candidate later stuck new slogans on those banners on 26 August.

As the contents on the banners with new slogan are different from the previous one, the banners with new slogans should be regarded as a new EA. The candidate is required, instead of providing the Notification of Correction to correct the particulars of the EA provided previously, to provide a new Information Sheet and 2 full colour photographs of the new EA to the RO by 29 August. The Information Sheet should be filled in with reference to **Example 8.1**.
