Notes on Completion of Notification of Corrected Information
in relation to Election Advertisements

1. 根據《選舉管理委員會（選舉程序）（選舉委員會）規例》（第 541I 章）第 107(1) 條，「發布」是指印刷、展示、展覽、分發、張貼、公布或以其他方式使公眾獲知，並包括繼續發布。
According to section 107(1) of the Electoral Affairs Commission (Electoral Procedure) (Election Committee) Regulation (Cap. 541I), “publish” means print, display, exhibit, distribute, post up, publicly announce or make publicly known by any other means, and includes continue to publish.
2. 「准許」是指私人土地的擁有人或佔用人或政府土地的主管當局根據《公眾衛生及市政條例》（第 132 章）第 104A(1) 條，就候選人在該土地展示或張貼招貼或海報而給予的書面准許。
“Permission” means the written permission of the owner or occupier of any private land or the authority of any government land given pursuant to section 104A(1) of the Public Health and Municipal Services Ordinance (Cap. 132) for a candidate to display or affix a bill or poster on such land.
3. 「同意書」是指任何人或組織根據《選舉（舞弊及非法行為）條例》（第 554 章）第 27 條，就候選人發布或授權發布收納了該人或組織的姓名、名稱或標識或跟該人或組織有關聯的姓名、名稱或標識；或與該人或組織的姓名、名稱或標識或與跟該人或組織有關聯的姓名、名稱或標識甚為相似的姓名、名稱或標識；或該人的圖像的選舉廣告，而給予的書面同意。
“Consent” means the consent in writing given by any person or organization pursuant to section 27 of the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554) for a candidate to publish or authorize the publication of an election advertisement that includes the name or logo of or associated with the person or organization; or a name or logo that is substantially similar to the name or logo of or associated with the person or organization; or a pictorial representation of the person.
4. 候選人必須確保提供的選舉廣告詳情符合《選舉管理委員會（選舉程序）（選舉委員會）規例》（第 541I 章）第 108 條及《選舉委員會界別分組選舉活動指引》第八章的規定及要求。如候選人需就印本方式作公眾查閱的選舉廣告資料摘要提供修正資料，必須藉專人送遞或郵遞向有關界別分組的選舉主任提供此修正通知書。
A candidate must ensure that the election advertisement particulars provided comply with the rules and requirements as set out in section 108 of the Electoral Affairs Commission (Electoral Procedure) (Election Committee) Regulation (Cap. 541I) and Chapter 8 of the “Guidelines on Election-related Activities in respect of the Election Committee Subsector Elections”. A candidate is required to complete this “Notification of Corrected Information in relation to Election Advertisements” (“Notification of Correction”) if he/she needs to provide corrected information related to the election advertisement(s) submitted in a hard copy format for public inspection. The candidate must provide this Notification of Correction to the Returning Officer for the relevant subsector by hand or by post.
5. 候選人只可用此修正通知書修正先前所提供的資料摘要內的選舉廣告資料（例如選舉廣告的類別、製作／印刷／發布日期、製作數量／印刷的文本數目、發布數量／發布的文本數目、製作人／印刷人的姓名或名稱及地址等）。如有關的選舉廣告內容有所修改，則應重新提供一份資料摘要。
A candidate may only make use of this Notification of Correction to correct information related to the election advertisement(s) on the Information Sheet provided previously (e.g. type of election advertisement, date of production/printing/publication, quantity produced/number of copies printed, quantity published/number of copies published, name and address of the producer/printer etc.). If the content of election advertisement(s) has been amended, the candidate should provide an Information Sheet afresh.

A candidate must provide the Returning Officer for the relevant subsector with the following information in respect of any correction to the type of election advertisements mentioned in this Notification of Correction –
 - (a) 每個選舉廣告的印本形式文本 2 份（或就每個實際上不能或不便以實物方式提供的選舉廣告，提供一式 2 份全彩色相片／打印本／影印本），以及與該些選舉廣告有關的准許及／或同意書的印本形式文本 1 份（如適用）；或
2 hard copies of each election advertisement (or 2 full colour photographs/printouts/photocopies of each election advertisement which cannot be practically or conveniently provided in specie) and 1 hard copy of each relevant permission and/or consent in respect of that/those election advertisement(s) (if applicable);
or

- (b) 載有選舉廣告的唯讀光碟（CD-ROM）或唯讀型數碼多功能光碟（DVD-ROM）一式 2 份，以及提供與該些選舉廣告有關的准許及／或同意書的印本形式文本 1 份（如適用）。

2 copies of the CD-ROM or DVD-ROM containing the election advertisement(s) and 1 hard copy of each relevant permission and/or consent in respect of that/those election advertisement(s) (if applicable).

7. 所有修正通知書必須不遲於選舉日後的 3 個工作天（即公眾假期及星期六以外的任何一天）內或在押後的選舉日後的 3 個工作天內（如適用）提供予有關界別分組的選舉主任。所提供的修正通知書，以及有關修正通知書第 1 段所指的資料摘要，會一同被視為其中一個依據，用以審查和核對候選人的「選舉開支及接受選舉捐贈之申報書及聲明書」。

All **Notifications of Correction** must be provided to the Returning Officer for the relevant subsector **not later than 3 working days (i.e. any day other than a general holiday and Saturday) after the polling day or not later than 3 working days after the postponed or adjourned polling day (where applicable)**. Any Notification of Correction provided with the Information Sheet mentioned at paragraph 1 of the relevant Notification of Correction will together be regarded as one of the bases for examining and checking the “Return and Declaration of Election Expenses and Election Donations” of the candidate.

8. 如尚未就某界別分組委任選舉主任，在此修正通知書中所提述選舉主任之處，均須解釋為提述總選舉事務主任。

If the Returning Officer has not yet been appointed for a subsector, the references in this Notification of Correction to a Returning Officer are to be construed as references to the Chief Electoral Officer.

Please note the following with regard to the provision of personal data in connection with this Notification of Correction –

(a) **資料用途**

就此修正通知書提供的個人及其他有關的資料，會供選舉管理委員會、選舉事務處、有關界別分組的選舉主任及其他有關政府部門和機構用於與選舉有關的用途。

Purpose of Collection

The personal data and other relevant information provided in this Notification of Correction will be used by the Electoral Affairs Commission, the Registration and Electoral Office, the Returning Officer for the relevant subsector and other relevant government departments and organizations for election-related purposes.

(b) **資料轉介**

有關界別分組的選舉主任在收到有關的資料摘要、此修正通知書、准許或授權書、同意書或選舉廣告樣本後，會將有關副本供公眾查閱，直至選舉申報書的文本根據《選舉（舞弊及非法行為）條例》（第 554 章）第 41 條可供查閱的期間結束為止。在展示前，如准許及同意書內有身分證明文件號碼及電話號碼，所有有關資料將會被遮蓋。就此修正通知書提供的個人及其他有關的資料亦可能會提供予其他獲授權的部門、機構或人士，包括但不限於法院，用於與選舉有關的用途。

Transfer of Information

A copy of the relevant Information Sheet, this Notification of Correction, permission or authorization, consent or election advertisement samples will be made available for public inspection by the Returning Officer for the relevant subsector who has received them until the end of the period for which copies of election returns are available for inspection pursuant to section 41 of the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554). In case there are identity document numbers and telephone numbers in the permission(s) and consent(s), all relevant information will be covered before display. The personal data and other relevant information provided in connection with this Notification of Correction may also be provided to other authorized departments, organizations or persons, including but not limited to the law courts for election-related purposes.

(c) **索閱個人資料**

任何人有權根據《個人資料（私隱）條例》（第 486 章）的條文要求索閱及改正他／她在此修正通知書所提供的個人資料。

Access to Personal Data

Any person has the rights to request access to and correction of the personal data he/she provided in this Notification of Correction in accordance with the provisions of the Personal Data (Privacy) Ordinance (Cap. 486).

(d) **個人資料保障原則**

候選人及代理人應留意，在收集第三者的個人資料以填寫此修正通知書時，須遵守《個人資料（私隱）條例》（第 486 章）附表 1 的保障資料原則，特別是第 4 原則，即採取所有切實可行的步驟，以確保個人資料受到保障而不受未獲准許的或意外的查閱、處理、刪除、喪失或使用。

Personal Data Protection Principles

Candidates and agents are reminded to observe the Data Protection Principles in Schedule 1 to the Personal Data (Privacy) Ordinance (Cap. 486) in collecting personal data of a third party in completing this Notification of Correction, in particular Principle 4 concerning the requirement to take all practicable steps to ensure that the personal data is protected against unauthorized or accidental access, processing, erasure, loss or use.
