## 填寫撤銷委任代理人通知書說明

### Notes on Completion of Notice of Revocation of Appointment of Agent

1. 候選人可隨時撤銷任何類別的代理人的委任。選舉代理人只可撤銷監察投票代理人或監察點票代理人的委任。  
A candidate may revoke the appointment of any type of agent at any time. An election agent may only revoke the appointment of a polling agent or a counting agent.

2. 就監察投票代理人或監察點票代理人委任的撤銷，候選人或其選舉代理人必須填上有關被撤銷的投票站，點票站或選票分流站的名稱。如果某人被撤銷委任為所有投票站的監察投票代理人或所有點票站（包括選票分流站）的監察點票代理人，請填寫“所有”。  
A candidate or election agent must fill in the name(s) of polling station(s), counting station(s) or ballot paper sorting station(s) of which the appointment of a polling agent or counting agent is to be revoked. If a person's appointment as a polling agent for all the polling stations or as a counting agent for all the counting stations (including ballot paper sorting stations) is to be revoked, please put "ALL".

If the notice of revocation is given before polling day, it must be delivered by hand, by post, by electronic mail or by facsimile transmission. If the notice of revocation is given on the polling day, it must not be delivered to the Returning Officer by post. The revocation of appointment is not effective until the notice is received by the Returning Officer/Presiding Officer/Chief Electoral Officer, as may be appropriate. The delivery methods of notice of revocation of appointment for agents are summarised below:

<b>監察點票代理人 Counting Agent</b>

投票日 On polling day	撤銷委任通知書可由候選人或其選舉代理人親自交付予有關投票站／點票站／選票分流站的投票站主任。 The notice of revocation may be delivered by the candidate or his/her election agent personally to the Presiding Officer for the relevant polling station/counting station/ballot paper sorting station.

4. 候選人或其選舉代理人應將撤銷委任通知書的副本交予被撤銷委任的人。  
A copy of the notice of revocation of appointment should be provided to the person whose appointment as agent has been revoked.

(a) **資料用途**

**Purpose of Collection**

The personal data and other related information supplied in connection with this notice will be used by the Electoral Affairs Commission, the Registration and Electoral Office, the relevant Returning Officer, the Presiding Officers of the relevant polling stations/counting stations/ballot paper sorting stations and other related government departments for election-related purposes.

(b) **資料轉介**

**Transfer of Information**

The personal data and other related information supplied in connection with this notice may be provided to other authorised departments or persons including but not limited to the law courts for election-related purposes.

(c) **索閱個人資料**

任何人有權根據《個人資料（私隱）條例》（第486章）的條文要求索閱及改正他／她所提供的個人資料。

**Access to Personal Data**

A person has the right to request access to and correction of the personal data he/she supplied in accordance with the provisions of the Personal Data (Privacy) Ordinance (Cap. 486).

(d) **個人資料保障原則**

候選人／選舉代理人在收集第三者的個人資料以填寫此通知書時，須遵守《個人資料（私隱）條例》（第486章）附表1的保障資料原則，特別是第4原則，即採取所有切實可行的步驟，以確保資料受到保障而不受未獲准許的或意外的查閱和處理。

**Personal Data Protection Principles**

Candidates/Election agents are reminded to observe the Data Protection Principles in Schedule 1 to the Personal Data (Privacy) Ordinance (Cap. 486) in collecting personal data of a third person in completing this notice, in particular Principle 4 concerning the requirement to take all practicable steps to ensure that personal data are protected against unauthorized or accidental access and processing.
