COMPILATION AND PUBLICATION OF THE 2025 SUBSECTOR REGISTERS

It is hereby notified that pursuant to section 14(1AB) of the Schedule to the Chief Executive Election Ordinance (Cap. 569), in respect of the compilation and publication of the 2025 Election Committee subsector (“subsector”) provisional register and subsector final register, the Electoral Registration Officer has specified—

- (i) 24 June 2025 by which the subsector provisional register must be compiled and published; and
- (ii) 21 July 2025 by which the subsector final register must be compiled and published.

It is hereby notified that, consequent on the exercise of the power under section 14(1AB) of the Schedule to the Chief Executive Election Ordinance (Cap. 569) in respect of the 2025 subsector provisional register and subsector final register, the Electoral Registration Officer has advanced the following dates or periods stipulated under the Electoral Affairs Commission (Registration) (Electors for Legislative Council Functional Constituencies) (Voters for Election Committee Subsectors) (Members of Election Committee) Regulation (Cap. 541B) and the Election Committee (Registration) (Voters for Subsectors) (Members of Election Committee) (Appeals) Regulation (Cap. 569B)—
